CHAPTER OFFICER REPORTS

PRESIDENT- John Forshee

It has been my honor and privilege to serve the membership of the Alpha Rho Chapter of ESP during our 2017-18 program year. Our membership brochure outlines the many, many benefits of ESP membership that focus on the development of the Extension Professional. I have long argued that the greatest benefit that I receive from my ESP membership is the opportunity that it has provided me to work with Extension Professionals from across the state, across the nation, and across many disciplines that I would not otherwise have had the opportunity to work with. You all are my greatest inspiration and I thank each of you for your dedication as we deliver our research based programming to all of Kansas.

The Alpha Rho Council and I set the following goals for our chapter for the 2017-18 program year.

- Reaching out to younger colleagues to get involved in ESP- explore how we can be relevant to younger colleagues and meet their needs.
- Review Associate membership in light of new national guidelines for immediate eligibility.
- Reach out to increase membership among specialists.
- ESP Area Directors assign ESP mentors for new colleagues.
- Kansas award applicants in all recognition categories.
- Professionalism Committee offer professional development opportunities for members.

We did great work in some of these areas and some we need to continue with or eliminate for next year. I want to thank my entire officer team, committee chairs, and national meeting planning committee for all that we have accomplished. You all have done great work!

It has been fabulous to welcome a number of new agents and specialists to K-State Research and Extension as I have been able to share information about ESP at two new agent luncheons. We have emphasized the ability of local units and departments to pay dues to assist new agents and specialists with membership. We continue to work in our professionalism and other committees at both the state and national level to make sure we are relevant to young professionals and to offer professional development that meets their needs where they are at. One example is that we encouraged the national planning team to live-stream our major presenters at National Meeting and that will happen for the first time in 2018 from Kansas!

Our membership committee and our constitution and bylaws committee researched, developed proposed changes, and educated the membership around the new membership guidelines that were passed by our membership via Zoom meeting and electronic voting. The changes more closely align the Alpha Rho Chapter membership guidelines with our national guidelines. This committee has also worked with KS JCEP to propose ESP changes that are necessary following the conversion of KEAA to KS JCEP.

Our State Director has reached out to new specialists and we will add new members from this area to our ranks this fall.

One goal we did not accomplish is the assignment of ESP mentors to new agents. However, I encourage all seasoned ESP members to "adopt" a new agent and help them navigate ESP membership to maximize their professional development opportunity. We will address this goal again in 2018-19.

Congratulations to our numerous state and national award winners. We are proud of you. Best of luck to

those who have applied for grants and scholarships as they implement innovative programming or further their professional development or education. We are fortunate to have an endowment that allows us to award and reward our members in this way. I urge our members to consider the ESP Endowment as you plan your annual charitable giving.

A special thanks to Jennifer Wilson and Stacey Warner who have headed up the planning team for the hosting of our ESP National Meeting in Manhattan, Kansas on October 1-4, 2018. These two have spent countless hours in communication with our National Executive Director Team and our National Board to make sure our planning was on point and ahead of schedule. Our committee chairs have done an outstanding job in getting their respective tasks completed. ESP national has continued to be impressed with the efficiency and timeliness of our planning. SECRETARY- Linda Beech

Minutes of the Alpha Rho Council meetings were written, reviewed and submitted for posting to the chapter website. The 2018 annual report was prepared with information provided by the officers and committee chairs.

Additionally, it was my honor to represent our chapter at the Joint Council of Extension Professionals (JCEP) Conference in Orlando, FL on February 14-15. I gained several innovative ideas from other ESP chapters which were shared in the May 2018 chapter President's Message.

TREASURER- Jennifer Wilson

As of September 5, 2018 the checking account balance is \$15,493.40 and the CD balance is \$5714.37 for total assets of \$21,207.77. Receipts for 2017-18 were \$8,931.46 and expenditures were \$5,458.49. The principal balance of the ESP Endowment fund as of August 31, 2018 is \$154,904.18.

EDITOR- Sarah Maass

The Summer/Fall (August) newsletter was published and posted on our Alpha Rho Chapter website along with a link that was emailed to all members. Thanks to all officers, committee chairs and members for submitting information to include in our chapter newsletter. Hard copies of the newsletter were mailed to all retirees by the Extension Operations Office. The ESP Annual Recognition Reception program booklet was prepared and will be available at Annual Conference.

HISTORIAN- Doug Jardine

Documents from the 2017 annual business meeting were deposited in the chapter's archives located at KSU Hale Library. As you all know, Hale Library was significantly damaged by a fire on May 22, 2018. While damage from the fire itself was minimal, water and smoke damage forced the closure of the library. Repairs and restoration are ongoing, however, the library will not be open for the 2018-19 academic year. Current archived materials are not available, nor can we deposit any new materials. I will hold materials from this year until the archives are reopened.

PAST PRESIDENT/ENDOWMENT CHAIR- Nadine Sigle

The ESP Extension Endowment Fund was established in 1992 and contributions and investment returns to the fund have provided financial support for more than 100 grants totaling in excess of \$107,140 to Kansas Extension professionals. Grants are used to improve educational programming and enhance opportunities for professional development.

Innovative Programming Grants – Jaime Menon and Jan Steen, Community Vitality, \$3,800 for the development of "Community Perceptions"; Jeanne Falk Jones, NW Area Office, \$2,200 for the development of "Managing Farm Stress: Both Economic and Mental Stress"; Jennifer Wilson, Riley County, \$1,500 for the development of "Teaching with Technology"; and Sarah Maass, Central Kansas District and Lindsey Mueting, McPherson County, \$1,500 for the development of "Robots and Beyond, Youth STEM Programming".

COUNCIL DIRECTOR REPORTS

I contacted new agents in the SE region about the opportunity to join ESP and the benefits a member has. I sent out an early message and then one just before the deadline for this year. I had good response with renewals and new members.

STATE DIRECTOR- Stacey Warner

I've communicated with state chapter members through the year about submitting nominations for awards and about bringing items to the annual conference auction. I also communicated with new employees on campus about ESP membership.

RETIREES DIRECTOR- Marie Blythe

Current year retirees were invited to maintain their commitment and involvement in the Alpha Rho chapter

of Epsilon Sigma Phi by becoming life members. An information sheet was sent that outlined opportunities and benefits of becoming a life member.

STANDING COMMITTEES

ANNUAL RECOGNITION EVENT- Jennifer Carr

The 2018 Annual Recognition Reception will be held on Tuesday, October 16 in the K&S Ballrooms of the Kansas State University Student Union. Because all K-State Student Union function space is reserved for Annual Conference, including the room assigned for this event, there is no rental fee for ESP. Plans include using Bockers II Catering. They will be providing a light desert reception, drinks and the linens for the event. The menu will consist of cheese trays, brownie bites, mini cheesecakes and dipped fruit. The table decorations will be provided at no cost by the committee. The cost of tickets will be \$15.00.

BUDGET AND AUDIT- Debra Wood

Debra Wood finished out the remainder of the year as chair upon the resignation of Gina Aurand. The Budget and Audit Committee met with the chapter treasurer Jennifer Wilson via Zoom on August 14. The committee reviewed 2017-18 expenditures to date to develop a proposal for the 2018-19 fiscal year. At the time of the call, the membership was voting on a proposed bylaws change to eliminate associate membership. Two budgets were discussed, one with bylaw passage and one without. In early September the committee communicated by email to finalize the proposal with all dues receipts under the Annual Member line item.

With the move to electronically renew dues online through the National ESP website there have been some challenges to work through. The proposed budget reflects the state portion only in the receipts, and no expenditures back to national. Line items were adjusted to reflect the committee's best estimate of receipts and expenditures for the coming year. A slight deficit budget is being proposed, but the committee feels we have the reserves in checking to cover this.

Mary Lou Odle and Debra Wood will work with Chapter Treasurer Jennifer Wilson to conduct the annual financial review of the treasury and to report at the Annual Business Meeting to be held at the KSRE Annual Conference.

CONSTITUTION AND BYLAWS- Jill Martinson

The constitution and bylaws committee met via Zoom on Tuesday, August 28, 2018. Changes to the constitution were limited to those recommended by the membership committee and approved by the membership on August 22 to eliminate the associate membership category.

The committee forwarded the following suggested bylaw changes to the general membership for consideration at the annual meeting in October:

1) Addition to Article 1, Section 2: "Special meetings may be conducted using distance technologies provided it is easily accessible to the membership."

2) Change in Article 4, Section 2: "Extension Director" changed to "Director for Extension" in order to reflect current administrative title.

3) Strike in Article 6, Section 2 (a): "Associate members are eligible for committee membership", as we no longer have associate members.

4) Addition to Article 7, Section 1 (a): "A portion of each member's yearly dues will be forwarded to the Kansas Joint Council of Extension Professionals (KS-JCEP) as set annually by the KS-JCEP Executive Board. This fee covers membership in KS-JCEP with all the rights and privileges of a voting member."

5) Strike Article 8, Section 2: Membership Card, as membership cards are no longer provided.

6) Replacement in Article 10: reference to the Director of Extension or Associate Director will be changed to "Director for Extension (or a representative)", in order to reflect current administrative title.

The committee also asked that the ESP Council discuss and have a recommendation for the membership at annual meeting about how KS-JCEP representation will be determined.

ENDOWMENT AUCTION- Jodi Besthorn

The Endowment Auction Committee has some great items for the annual silent auction, which will be held on Tuesday, October 16 during the poster and reception time. The committee has communicated the information via the listserv and the Tuesday Letter. In addition, each area ESP director was asking to work with their members and provide a gift basket for the auction. Confirmed items include: locally grown honey, Kansas wine, N-zone gift certificate, Mary Kay products, Land of Kansas Basket, designer KSU coasters, pen set and other great items. The auction will run for 1 hour only and will close at 5:30, so winners have time to pay and collect their items prior to the event festivities. GLOBAL RELATIONS- Charlotte Olsen

The committee had no meetings this year; however, several ESP members have been on the Navigating Difference training team and have held two training sessions during the past year. There also has been representation on the initiative related to the Intercultural Development Inventory. In addition, a new Extension resource, "Build Intercultural Relationships for Better Understanding of Your Neighbor," has been authored by ESP members.

MEMBERSHIP RECRUTMENT AND RETENTION-Stacey Warner

The committee met several times early in the year to study the chapter's associate membership category for individuals in their first three years of membership. The committee proposed a change to the constitution and by-laws that eliminated associate membership and allowed new members to pay national dues only during their initial year of membership. The change was passed in a special meeting of the chapter held via Zoom on August 14. This revision will allow first year members to have the benefits of both national and chapter membership.

MEMORIAL- Jeanne Falk Jones

Dr. Bob Newsome passed away December 16, 2017 in Manhattan, Kansas.

Dr. Newsome began his Kansas Extension career in 1955 as McPherson County Agricultural Agent. In 1956, he moved to Jefferson County Agricultural Agent. His next position was as Riley County Agricultural Agent starting in 1960 and was named Riley County Extension Director in 1967. He was promoted in 1979 to Northeast Area Extension Director and he remained in that position until his retirement in 1994.

Dr. Jack Riley passed away December 26, 2017 in Manhattan Kansas.

Dr. Riley came to K-State in 1971 as an Associate Professor in Animal Sciences and Industry. He was the faculty coordinator of the Beef Research Unit for 16 years and coordinator of all research activities for the department for three years. In 1987 he was named Department Head and served in that capacity for 17 years until 2004 when he entered phased retirement and returned to a part-time faculty teaching position. Dr. Riley retired in 2010.

Fred D. Atchison, Sr., retired Area Extension Forester, formerly with Kansas State and Extension Forestry, passed away April 4, 2018 in Manhattan, Kansas. Fred was the father of Bob Atchison, Rural Forestry Coordinator, Kansas Forest Service.

Fred Atchison served as an Area Extension Forester with K-State and Extension Forestry for 23 years beginning at the Fort Hays Experiment Station in 1964. In 1978 he transferred to Manhattan where he served as the Area Extension Forester until his retirement in 1987.

Deanne D. Wright passed away May 15, 2018 after a short illness in Wellington, Colorado.

Deanne began as an Extension Specialist,

Communications in 1970. In 1971 her title changed to Extension Specialist, Radio & Television. She resigned in 1975 to return to school, and returned in 1979 as Extension Specialist, Radio and TV. She remained in the same position until her retirement in 1995.

Herbert W. Bulk passed away on Monday, July 16, 2018 in Topeka, Kansas.

Herb started his Extension career in Leavenworth County as the County Agricultural Agent in 1949. He moved to Nemaha County Agricultural Agent in 1952. He became the Shawnee County Agricultural Agent in 1958 and was promoted to County Extension Director in 1972. He remained in that position until his retirement in 1984.

Ocie Taylor Neuschwander passed away Monday, August 13, 2018 in Tribune, Kansas.

In 1958, Ocie became the first full-time County Extension Home Economist in Greeley County. She retired from that position in 1981. She was honored to be the first Kansan to receive the Florence Hall award from the National Association of Home Economists.

Carroll V. Hess passed away Friday, August 17, 2018 in Topeka, Kansas.

Dr. Hess was appointed Dean of the College of Agriculture in 1966. During his tenure, he served abroad for four years in the Middle East (Oman) and two years in the Philippines for the U.S. Agency of International Development. He retired from Kansas State University in 1988.

NATIONAL ESP COMMITTEES

CHAPTER RELATIONS- Doug Jardine

This national committee is composed of national officers with the purpose of enhancing communication with state chapters and support from the national board. Training for local chapters was provided at the JCEP Leadership Conference and National ESP Conference on best practices for building and maintaining strong chapters and leadership training for chapter officers and those members interested in stepping up to leadership.

MEMBERSHIP RECRUITMENT AND RETENTION-Doug Jardine

This national committee focuses on strengthening chapters, recognizing chapter excellence in membership recruitment and retention, increasing ESP membership diversity and working to provide first time national meeting attendees with a positive experience. The committee updated the Achievement in Chapter Membership rubric and organized conference mentors for first-timers at the national conference in Manhattan.

SCHOLARSHIPS, GRANTS AND RECOGNITION-Laurie Chandler

This national committee is responsible for administering the recruitment and selection for various scholarship, grants and recognition opportunities. This year the committee awarded 7 scholarships and 1 mini-grant: PILD Scholarship (4), Angus Professional Development Scholarship (2), Redinger Administrator/Leader Scholarship (1) and a Professional Development \$1000 Mini Grant (1). Alpha Rho President-Elect, Erin Yelland received a PILD scholarship this year. The committee also reviewed applications for Friends of Extension award and recommended three individuals for recognition at the 2018 National ESP Conference. Last year, several scholarships were "left on the table" due to a lack of applications. As a result, a key goal for this committee this year and into the future is to work to increase the number of applicants submitting for awards and scholarship by 5%.

PROFESSIONALISM- Susie Latta

This year the committee marketed two professional development webinars to the membership on Healthy Transition to Retirement and Learning Digital Strategies.
