As the year draws to a close it's time to reflect upon the accomplishments of this past year. A big round of thanks is extended to the 2018 National Conference Steering Committee. The committee has already given Kansas a great name with their advanced planning abilities. "Vast Prairies...Endless Possibilities" is a conference all members will want to attend in 2018.

Another significant happening this year was the retirement of Daryl Buchholz as our Associate Director of Extension. Daryl's support to ESP at all levels has been a source of inspiration. We look forward to working with him as a life member. We welcome Gregg Hadley as our new Associate Director and look forward to building upon our existing relationship with him.

Other outcomes of the year include:

- Members met for the face-to-face annual business meeting on Tuesday, October 25, 2016 during the KSRE Annual Conference.
- Nine individuals were recognized with chapter awards at the recognition event.

- Five new associate members, 5 new annual members and one transfer member were initiated.

# **STANDING COMMITTEES**

#### **Budget and Audit - John Forshee**

The Budget and Audit Committee met with the chapter treasurer Jennifer Wilson on September 8 via Zoom to review the 2016-17 budget and to develop a budget proposal for 2017-18. Based upon the actual

expenses for 2015-16 and 2016-17 the committee proposed adjustments to line items that we felt reflected what would actually happen. The committee also adjusted the revenue and expense items for dues to accurately reflect the revenue stream with the membership dues now flowing through National first and then back to the state rather than the state first and on to national.

The committee is hopeful that the revised guidelines for Extension Units to have the option to pay association dues from non-appropriated funds will result in increased membership for ESP. You will see an estimated increase reflected in the membership number of the budget.

Debra Wood and Gina Aurand (past chair and chair-elect of the committee) were assigned to work with Chapter Treasurer, Jennifer Wilson to conduct the annual financial review of the treasury and to report at the Annual Business Meeting to be held at the KSRE Annual Conference.

# Memorial Committee- Amy Lorenzen

William Lawrence Blair began his career with the Kansas Cooperative Extension Service in Butler County as a county club agent in 1960; he moved to Lyon County and served in the position as agricultural agent in 1961 and resigned in 1963. In 1964, he was rehired as the Linn County Agricultural Agent and remained in that position until his retirement in 1992.

**W. Gale Mullen** was appointed as assistant county club agent in Brown County in 1950. He then moved to Russell County later that year where he served as county club agent until 1955. He then moved to Allen County where he served as the county agricultural agent. He resigned in 1956 to work in the private sector. He was reappointed in 1957 as a county agricultural agent in Neosho County. He became the Area Extension Agricultural Economist in Farm Management in 1961, located in Erie, Kansas. He remained in that position until his retirement in 1982.

**Ross M. Nelson** began his career with the Kansas Cooperative Extension Service as assistant county agriculture agent in Shawnee County from 1957 to 1958. He was reappointed in 1960 to Franklin County as their county club agent. In 1964, he moved to Washington County as county club agent. In 1966, he was named the Logan County agricultural agent and served as county extension director until 1981, when he moved to Ellis County and served as the agriculture agent and county extension agent until his retirement in 1987.

Alice "Lois" Redman started her Kansas Extension career in 1978 as an extension specialist in 4-H and Youth Development. She remained in that position until her retirement in 1988. Lois had also worked in Missouri Extension and Oregon Extension before coming to Kansas. Her most notable accomplishments during her tenure at Kansas State University include: the establishment of the 4-H/Labo Japanese Exchange Program, leadership for the IFYE and Kansas-Paraguay Partners programs. She was awarded the Distinguished Service Award from Epsilon Sigma Phi for her work in international programs. Lois was inducted into the National 4-H Hall of Fame in 2009.

**Dr. C. Stephen Scheneman** came to Kansas in 1989 as Leader, Extension Professional and Organizational Development. He retired from this position in 2001.

**Norman Warminski** began his career with Kansas Extension in 1968 as a county extension horticulture agent in Johnson County. In 1969, he moved to Harvey County as county extension 4-H agent. He became county extension horticulture agent in Sedgwick County in 1970. He remained in this position until his retirement in 1999.

Herman W. Westmeyer began his career in the Kansas Cooperative Extension Service as a county extension agent in 1936 in Lane County. He moved to Barber County in 1940 and Harper County in 1941. He left for military service in World War II in 1942. During the war, Herman saw action in the European Theatre during the Battle of the Bulge. He received a Purple Heart for serious wounds received during the battle and was awarded a Bronze Star medal for valor. Following his military service, he returned to the Kansas Cooperative Extension Service as a county agent in Harvey County in 1946. He moved to Ford County in 1947. In 1961, after earning a master's degree, he started a new role as Extension Beef Cattle Specialist on campus. Herman transferred to the Southeast Area Extension Office in Chanute in 1973 as the Extension Beef Cattle specialist. In 1975, he was promoted to the Southeast Area Extension Director. He retired from that position in 1978 and was granted Professor Emeritus status.
