A motion was made by Smith and seconded by Douthit to approve the expedited proposals. Brief question about ENTOM 399. Undergraduate research courses, when they first began several years ago, were to be in the 400 level, but it did not seem there were any negative consequences to

changing the course level and it was determined a few other research courses had also done that. Motion carried.

- 7. University Calendar Committee Proposed three-year academic calendar for KBOR (FA25-SU28) Brundage shared the information regarding the proposed three-year calendar with members. This is for the committee's notification, and it will move forward for a vote at the FS meeting in December. There were a couple clarifying questions on the fall break/thanksgiving holiday and how it was laid out and about the KSUnite event that has been held each fall now for the past five years and whether it needs documented in the academic calendar for our own internal part so that instructors will know to expect the canceling of classes when this comes around. Brundage will take this feedback to the calendar committee as they have discussion over future calendars.
- 8. Proposal for general education K-State Core
 Bennett shared they have been working on the proposal, even up to this morning, based on feedback
 received from various colleges. Committee members went through the proposal section by section and
 made changes as needed. There was conversation about systemwide transfer courses and in which
 buckets some of them need to be in; that will be verified this week. Relating to the format of the
 proposal, it was believed that having the shorter, or summarized version, is good, but it may be wise to
 have a link to the full details included within that version. Perhaps a hyperlink to a pdf. This will hopefully
 address any concern that something is missing. Two amendments were made during discussion on the
 draft proposal. A motion was made and seconded to accept performance courses within bucket #6.
 Motion to amend carried. A motion was made and seconded to allow for double dipping or allowing one

Lengthy discussion continued. Some clarity was also provided that once the core is approved and the disciplinary councils are in place, a proposal can be reviewed whereby a college can request to be included as a disciplinary unit, instead of simply trying to put forward courses for inclusion. It was agreed more clarity will be gained as we progress. To propose to be a disciplinary unit is different from proposing to add a course for inclusion and does not really fit within curriculum procedures and the ARN procedures document, but it may be good to include some language related to this, perhaps in a future iteration.

Based on review of the draft proposal, amendments made today, and official amendments received from faculty to be considered during the final vote, committee members voted to approve the K-State Core proposal. Official amendments to the Core that have been submitted will also move forward with the proposal. One final email review will occur prior to the FS Executive committee reviewing this for placement on the FS agenda as a first reading. It should be noted that included in the proposal are the actions to retire the K-State 8, approve changes to University Handbook, Section F120, and approve changes to the Approval, Routing, and Notification procedures. Senator Bennett will also inquire of the Executive Committee about the best way to share caucus statements. For example, there was a statement from one caucus that did not necessarily fit as an amendment, so the question was whether to officially include it with the proposal or perhaps have it as a supplementary document. This will be something the FS Executive committee will need to determine.

Additionally, all were reminded that amendments to this proposal will be needed in writing approximately 15 days prior to the final vote. All were thanked for their valuable feedback and contributions in this process.
