Ms. LaBerge reported that just this afternoon it was discovered that DAS 197 did not actually need Gen Ed Council approval, so it *is* ready to be acted on by this committee. Due to this being the first set of proposals sent to this body having been approved by the Gen Ed Council, and the fact there were some questions, we asked if interim provost Gonzalez was available to join. She did join Academic Affairs later in the meeting. In the interim, a motion was made by Bennett and seconded by Smith to approve DAS 197. Motion carried. After Tanya joined, she was able to confirm that wording was slightly different for some of them, though not intentional -- it was just the first go around with these and some pieces were missing, such as the justification from the faculty advisory board, and so she was working to include necessary information. All courses moved forward from the Gen Ed Council

were in support of the faculty advisory board. The council made one recommendation to the course title for LAR 298, but that will need consideration by the college. That information was recorded in the Curriculog proposal as well. The comments shared by Tanya provided reassurance to the committee.

The Gen Ed Council will continue evaluating courses as they come through and unlike the curriculum proposals that are on a tight deadline, these will move through at regular intervals. If they come to us after the fall 2024 deadline has passed for Faculty Senate, it doesn't appear that there will be an issue with this and projected terms will be pushed out, unless there is an exceptional need. Otherwise, they will move forward on the normal timeframe. After this conversation, a motion was made by Smith and seconded by Prakash to approve the rest of the courses above. Motion carried.
