AGRICULTURE – Amendment #1

Approval, Routing, and Notification for Modifying the K-State University Core

- The Provost will form a Kansas State University General Education Council, comprised of Associate Deans for Academics at each undergraduate-serving college or campus, or their designee. Proposals to change the list of approved disciplines or courses should be submitted to the General Education Council. Note that 100- and 200-level courses in disciplines specified by the KBOR Framework and courses approved for statewide transfer may **not** be removed from the list of approved courses.

- A General Education Committee Disciplinary Advisory Board will be formed for each of the general education areas. **The Provost General Education Council** will make initial staggered appointments for three faculty members for each of the disciplinary areas, two of whom will be from the disciplines approved on the K-State University Core for those requirements. Faculty will serve three years. After the initial appointments, Kansas State University General Education Council will appoint the Disciplinary Advisory Board members following the composition of two faculty from the disciplines approved on the K-State University Core and one additional faculty.

- The General Education Council will forward courses proposed for inclusion to the appropriate Advisory Board for that area. After receiving the Advisory Board report, the Council should decide whether to recommend the course for inclusion or not. Courses recommended for inclusion will be forwarded to the Faculty Senate Committee on Academic Affairs and will then be handled in the usual process.

Rationale:

The General Education Council provides equal representation from each college with college administrators who have robust familiarity with the expertise and experience of faculty within their colleges. As the committee selections will conduct the first round of precedent-setting course evaluations for the University Core, expertise in course content and curriculum need to be a strong skill set of those involved. It would seem the General Education Council is better suited to make the decision of which faculty should initially comprise the committees. Knowing the three-person committees for each bucket were selected in a process where each college had an equal voice also helps with collegiality and trust in the process.
