Kansas Public Employees Retirement System (KPERs) (401[a] Plan)	Employee pays 4% of gross salary	Tier 1: Mandatory participation at date of hire (eff 7/1/2009)	Employees hired <b>before 7/1/2009 or vested KPERs members returning to work:</b> Eligible for retirement benefit at age 65 with any number of years' contributions; age 62 with 10 years' contributions; or combination of age and years of contributions equaling 85 points. Reduced benefit for early retirement at age 55 with 10 years of service credit. Reduced benefit for early retirement at age 55 with 10 years of service credit. Retirement is based upon salary and years of service.								
<b>Voluntary Retirement Savings Plans</b>											
Voluntary 403(b)	Employee	Upon employment	Employees may contribute to a voluntary retirement plan to the maximum limit allowed by the Internal Revenue Code. Leave is adjusted and prorated based upon the number of hours worked within a pay period. Sick leave may be used for employee's personal illness or for qualified medical care. Accidental Death Benefit	K-State	Upon employment	The employment-connected accidental death benefit is provided to any benefits-eligible employee who, at the time of death, is actively participating in the Kansas Public Employees Retirement System (KPERS) retirement plan or the KPERS waiting period. Teachers and Employees Association (TEA) Optional	Employee	Upon employment	\$10,000 to \$250,000 with a maximum of 5 times annual salary coverage available. 	K-State	Upon employment	If approved, benefits start after a minimum of 180 days of continuous and total disability and are paid monthly.
