

2011-2012 YEARLY BUDGETS FOR STUDENTS

To apply for F-1 or J-1 student documents, students are required by USCIS to demonstrate sufficient financial support. Kansas State University cannot produce I-20s or DS-2019s without proper documentation. When submitting materials for an I-20 or DS-2019 to be issued, you must attach financial support documentation equal to or exceeding the amount of expenses listed below. The figures are estimated costs, subject to change, and are updated annually based on cost of living and tuition increases. Tuition and fees estimates are for the minimum number of required hours for each classification. If you intend on enrolling in more than the required number of credit hours during a semester, you can view the tuition and fee rates at <http://www.k-state.edu/controller/cashiers/tuitionfeesinfo.html> in order to determine any differences in the estimated costs.

Estimates for Undergraduates, English Language Program, and Salina campus are calculated for the academic year (9 months). Estimates for Graduate students are calculated for the academic year plus summer semester (12 months). Individual student needs may vary.
