The purpose of the K-State Flying Club is to promote interest in aviation. We do this by providing airplanes for members at the most economical rates possible. The corporation owns and operates four aircraft, and we strive to maintain a ratio of 13 active members per airplane.

Membership in the K-State Flying Club is open to the public; however, priority is given to K-State Students, Faculty, Staff and Alumni.

To join the corporation, you must buy a share of stock for \$300 which is refunded when you resign from the corporation. You must also pay a \$60 non-refundable processing fee. Monthly dues are \$35 and you should try and fly at least 1 hour each month. Members flying corporation planes are covered for \$1,000,000 liability.

If you're currently a licensed pilot, you'll need to be checked out by one of our corporation-approved instructors before you can fly any of the club's aircraft.

Listed below are corporation-approved flight instructors available for instruction at all levels of training from the private pilot's license through the commercial certification. The cost of obtaining a private pilot certificate is dependent on individual ability, but will usually cost between \$4,000 and \$5,000.
