Virginia Durant LGBTQ+ Scholarship

Biography	The K-State Spectrum Center in Student Belonging and Inclusion in partnership with the Virginia Durant family, have created this scholarship to recognize the contributions of a LGBTQ+ or allied student. The scholarship is for the 2024-2025 academic year. The ideal candidate shall be recognized as a leader within the minoritized sexuality and gender identity community and as a leader who promotes diversity and social justice for all people. Preference will be given to a student who identifies as a first- generation student in higher education. In all other respects, this scholarship shall be awarded without restriction to race, sex, gender identity, national origin, religion, age, sexuality, or disability.	
Eligibility	The applicant of the scholarship must meet the following criteria to receive the scholarship. If applicant does not meet all the criteria, they may address and appeal in their essay to be submitted.	
	1. The recipient(s) of this scholarship will be a student properly enrolled in any curriculum at Kansas State University.	
	2. The recipient(s) must have a minimum cumulative GPA of 2.5, based on a 4.0 scale.	
	3. The recipient(s) must be a permanent resident of the United States.	
Other Criteria	The applicant must submit all of the following materials to be considered for the scholarship.

Selection Timeline	A scholarship committee comprised of university faculty and staff will choose the recipient. Applicants will be informed by email of the award selection. The scholarship will be awarded for the spring semester and checks will be made to Kansas State University for a tuition stipend.
