

## Joseph Nisil Jr. Memorial Veterinary Medicine Scholarship

---

<b>Biography</b>	The K-State Spectrum Center in Student Belonging and Inclusion, in partnership with the Junction City Teddy Bears, have created this scholarship to recognize the contributions of former Veterinary Medicine employee, Joseph Nisil Jr. The scholarship is intended to be received by a LGBTQ+ or allied student who is enrolled in Veterinary Medicine or pre-veterinary studies at Kansas State University for the 2024-2025 academic year. The ideal candidate shall be recognized as a leader within the minoritized sexuality and gender identity community and as a leader who promotes diversity and social justice for all people. In all other respects, this scholarship shall be awarded without restriction to race, sex, gender identity, national origin, religion, age, sexuality, or disability.
<b>Eligibility</b>	<p>The applicant of the scholarship must meet the following criteria to receive the scholarship. If applicant does not meet all the criteria, they may address and appeal in their essay to be submitted.</p> <ol style="list-style-type: none"><li>1. The recipient(s) of this scholarship will be a student properly enrolled in any curriculum at Kansas State University.</li><li>2. The recipient(s) must have a minimum cumulative GPA of 2.5, based on a 4.0 scale.</li><li>3. The recipient(s) must be a permanent resident of the United States.</li></ol>
<b>Other Criteria</b>	<p>The applicant must submit all of the following materials to be considered for the scholarship.</p> <ol style="list-style-type: none"><li>1. Applicants Information Page</li><li>2. Essay Submission</li><li>3. Signed Release of Information Form</li></ol>
<b>Selection Timeline</b>	A scholarship committee comprised of university faculty and staff will choose the recipient. Applicants will be informed by email of the award selection. The scholarship will be awarded for the spring semester and checks will be made to Kansas State University for a tuition stipend.
