

Mary Kay Siefers Leadership Scholarship

Biography

The K-State Spectrum Center in Student Belonging and Inclusion in partnership with university faculty and staff, have created this scholarship in recognition of the accomplishments and contributions of Dr. Mary Kay Siefers. The scholarship is intended for a student who is enrolled in any discipline at Kansas State University for the 2024-2025 academic year. The ideal candidate shall be recognized as a leader within the minoritized sexuality and gender identity community and as a leader who promotes diversity and social justice for all people. In all other respects, this scholarship shall be awarded without restriction to race, sex, gender identity, national origin, religion, age, sexuality, or disability.

Eligibility

The applicant of the scholarship must meet the following criteria to receive the scholarship. If applicant does not meet all the criteria, they may address and appeal in their essay to be submitted.

- 1. The recipient(s) of this scholarship will be a student properly enrolled in any curriculum at Kansas State University.
- 2. The recipient(s) must have a minimum cumulative GPA of 2.5, based on a 4.0 scale.
- 3. The recipient(s) must be a permanent resident of the United States.

Other Criteria

The applicant must submit all of the following materials to be considered for the scholarship.

- 1. Applicants Information Page
- 2. Essay Submission
- 3. Signed Release of Information Form

Selection Timeline

A scholarship committee comprised of university faculty and staff will choose the recipient. Applicants will be informed by email of the award selection. The scholarship will be awarded for the spring semester and checks will be made to Kansas State University for a tuition stipend.
