<u>Steps for BS/MPH on website with printable PDF</u>. If a student takes a required class as an undergraduate, we do not make them re-take the class; they choose an additional elective in their emphasis area.

Questions about process? <u>Please send us your undergraduate academic advisors so we can let them know about</u> the program/process.

Steps	Instructions
1	Student visits in Junior or Senior year with undergraduate advisor and/or MPH program to see if eligible for Graduate School (minimum GPA of 3.0). Student will be required to take the GRE and submit scores with Graduate School Application.
2	Student and undergraduate advisor select classes that <u>may</u> be used for both programs AND the courses <u>have not been taken</u> thus far in the undergraduate curriculum. The MPH Program will accept any class (elective or required) for desired MPH emphasis area if on approved list.
3	Student visits with their financial aid advisor and understands any financial aid ramifications. An e-mail from the financial aid advisor to the MPH Director would be helpful, and encouraged.
4	Undergraduate advisor responsible for notifying undergraduate department/college and putting note KSIS (when available in DARS and/or on transcript). Also sends an e-mail to MPH Director indicating support for the student in the BS/MPH program and identifies the classes to be used for both degrees and when they will be taken.
5	Student applies for the BS/MPH program and if admitted <u>THEN</u> enrolls in the shared graduate classes. (See notes below, especially note #1.)

When the student has completed 9 graduate credits, a POS will be prepared in conjunction with MPH major professor and submitted to the Graduate School, even if the student is still working on their undergraduate degree.

Notes:

- 1. <u>Special Enrollment Form</u>: The student may take the intended shared courses for graduate credit by utilizing the special enrollment form on the Graduate School's website (located under Miscellaneous forms), or a request for credit type change has been made during the current semester of enrollment (before rosters are released and final grades have been assigned). These credits would appear on the graduate record in KSIS and <u>may</u> count toward the graduate program regardless of when they are taken, if they are listed on the POS.
- 2. Change in Status. The student's status will change from undergraduate to graduate once the student is formally admitted to the program with the start semester listed on the Graduate Application. Taking courses for graduate credit using the Special Enrollment Form starts their graduate career/record, but their status remains undergraduate until the requested Graduate Application start semester. The student needs to be very careful to select the correct starting semester on the application. Generally, they should select the beginning of the last semester of their undergraduate degree if they receive federal financial assistance contingent on their undergraduate status to minimize the financial loss once this status change is made.
- 3. All credits listed on the Program of Study cannot be older than 7 years.
- 4. <u>No exceptions to the above</u>. The Graduate School will not move classes between the undergraduate and graduate records in KSIS once the class roster has been closed and a grade has been assigned.
 - <u>GRE requirement for applications.</u> Background and rationale: Currently required and used as an indicator for success in the program. Generally, anyone with a GPA below 3.0 is funneled to the Certificate program and if they complete at least 3 certificate classes with a 3.25 or above are allowed to complete the application for the MPH program without taking the GRE (re-write their statement of objectives and get 2 additional references). Guidelines from the graduate school is that admission requirements need to be consistent for all applicants so the GRE could not be required of some and not others.

• The remainder of the meeting was spent discussion the GRE requirement for applications or should we modify it.

The following were comments/observations from the discussion.

- + FNDH and KIN departments recently voted or are discussing to remove the requirement. FDSCI is waiving it at present for all applications due to COVID-19 and some testing centers being closed.
- + The GRE is a good standardized assessment for international students when we are not familiar with the grading used at each institution.
- + One faculty focuses more on their "State of Objectives" and goals and doesn't look at the GRE.
- + Some faculty over the last 5 years have changed their opinion about the value of the GRE. Previously, they felt it was an important tool, but now less so.
- + GRE can be used to review student applications with similar GPAs.
- + Do the benefits of the test outweigh the deterrents? Some students will not apply to programs that require the GRE, and many schools/programs are no longer requiring it, including CVM at K-State.

The MPH office will send out a survey for voting responses and comments/suggestions on updating the "Statement of Objectives."
