2 **CREATION OF THE SPECIAL**  
3 **COMMITTEE TO REVIEW EXPANSION**  
4 **PLANS FOR THE REC COMPLEX**

7 **WHEREAS,** In the Fall of 2007, K-State students voted in favor of expanding the Chester E. Peters  
8 Recreational Complex;

9  
10 **WHEREAS,** Student input should be considered by the architects during the design phase for the  
11 expansion of the recreational complex;

12  
13 **WHEREAS,** A special committee to assist in the design phase of the recreational complex expansion,  
14 and also review the architectural renderings, should be established; and

15  
16 **WHEREAS,** Appointments to this committee will be subject to Student Senate approval.

17  
18 **BE IT ENACTED THAT:**

19  
20 **SECTION 1.** There is hereby established the Special Committee to Review Expansion Plans for the  
21 Rec Complex with the following purposes:

- 22 a. Meet throughout the Summer of 2008 with the architects for the Chester E.  
23 Peters Recreational Complex expansion.
- 24 b. Provide student feedback during the design phase of the recreational complex  
25 expansion project.
- 26 c. Review the architectural renderings provided, while keeping the interests and  
27 needs of students in mind.
- 28 d. Arrange for a presentation to Student Senate by the architects at the  
29 beginning of the 2008-2009 school year.

30  
31 **SECTION 2.** The Special Committee to Review Expansion Plans for the Rec Complex shall be  
32 composed of:

- 33 a. The Chair of the Student Senate and the Student Body President, who shall  
34 serve as Co-Chairs of the Special Committee and shall be voting members.
- 35 b. At least seven students, all of whom are voting members. Members shall be  
36 jointly appointed by the Student Senate Chair and the Student Body  
37 President, subject to Student Senate approval.

38  
39 **SECTION 3.** The Special Committee to Review Expansion Plans for the Rec Complex shall submit its  
40 review to the Student Senate at the beginning of the 2008-2009 school year.

42 **SECTION 4.** From and after September 1, 2008, Bill 08/09/02 is hereby repealed.
