# Judicial Board Descriptions

Student Tribunal: Justices on Student Tribunal will hear appeals from cases heard by Student Review Board and the Residence Hall Boards. Appeals are generally decided based on the written record of the originating case. This board is also responsible for interpreting the KSU SGA Constitution, By-Laws and legislation, trying bills of impeachment when requested to do so by Student Senate, and hearing appeals arising from the SGA elections process. Due to this board's potential involvement in the election, *board members are prohibited from participating in any campaign-related activities while serving on Student Tribunal*, as per the SGA Elections Regulation Code. Student Tribunal generally hears fewer than 10 cases per academic year.

**4 positions available**

Student Review Board: This board hears cases involving violations of the Student Conduct Code that occur on campus, or at University-sponsored events, outside the Residence Halls. Justices on this board will often meet face to face with the parties involved. Professionalism in all situations is imperative for students who serve on this board. Review Board generally hears approximately 10-15 cases per academic year.

**4 positions available**

Parking Citations Appeals Board (PCAB): PCAB is comprised of students, faculty and staff. This board considers all appeals from the University community involving parking violations. This board does not meet together as a group. Appeals are separated and assigned equally to board members to review on an individual basis. All appeals are determined based on the written record. Board members might expect to read and decide approximately 100 appeals in a given academic year.

**6 positions available**

Judicial Council: Members on this board have a variety of tasks including sponsoring programs and raising awareness of the Judicial Branch on campus. They may hear some cases during the year, though in is unlikely.

**4 positions available** (1 spot reserved for a Student Senator)

All members of the Judicial Branch should possess the following traits:

- Open mindedness
- Ability to express ideas freely
