RE: Systemwide Transfer Course Numbering Adjustments in Spring 2023

In 2020, the Kansas Board of Regents (KBOR) put together a task force to work on a <u>systemwide</u> <u>general education</u> framework to enhance ease of transfer across Kansas institutions of higher education. On Wednesday, June 15, 2022 KBOR passed a <u>transfer policy</u> and the systemwide <u>general education framework</u> for implementation at all KBOR institutions by Fall 2024.

K-State began campus discussions about implementation throughout the summer of 2022. On January 24, 2023 Faculty Senate approved a policy and accompanying processes for implementation by the Fall 2024 KBOR deadline. We are now in the stage of transitioning from K-State 8 to K-State Core for our general education.

The K-State Core framework covers six disciplinary areas: English, Communications, Mathematics & Statistics, Natural & Physical Sciences, Social & Behavioral Sciences, and Arts and Humanities. In addition, a seventh area which K-State has designated as 6 credit hours of free electives. In total, the framework takes up 34-35 credit hours of 100 and 200-level coursework.

The KBOR general education framework stipulates that systemwide transfer courses in the six disciplinary areas are automatically included in our implementation. As indicated in the list below, K-State has over twenty 300- and 400- level courses that have been approved as equivalent to courses at Kansas two-year institutions.

If your department has a system-wide transfer course at the 300- or 400- level, we request an adjustment to a 100- or 200-level course by December 2023. You may use the course change forms to move through the approval process via Curriculog. If the course is currently an advanced course within the disciplinary major, we suggest you develop an entry-level version of the course.

This adjustment will assist in the alignment of these courses with others in the general education framework as well as move the campus toward a more standardized understanding of our course levels and what is appropriate for systemwide transfer as this process continues.

We know that some of these adjustments may have curricular repercussions for your majors and for other programs that use your courses. In order to maintain transparency and open communication of these changes across campus, please **communicate your adjustment plans** and timeline on <u>this excel spreadsheet</u> by March 15, 2023.
