- ❖ Choose a major that interests you & in which you excel

- ❖ Add Pre-Law designation & meet with your Pre-Law advisor

JUNIOR YEAR:

- ❖ Take the LSAT exam in spring or summer or early fall of senior year

LEAD | K-STATE to KU LAW



Earn your degrees in 6 years instead of 7!

Spend your first 3 years at K-State earning credit toward your bachelor's degree, then attend KU law school for 3 years to earn your juris doctorate degree. The credits earned after successfully completing the 1st year law school curriculum will transfer back to K-State to satisfy your remaining bachelor's degree requirements. The available majors for this program include:

Pre-Law is a non-degree designation added to a student's academic profile. There is no required major, coursework or curriculum. Pre-Law students have 2 advisors - a major advisor who assists in understanding the requirements to obtain a desired bachelor's degree and a Pre-Law advisor who helps students understand the requirements of a competitive law school applicant.
