

# COMMERCE BANK PRESIDENTIAL FACULTY AND STAFF AWARD FOR STUDENT BELONGING

**PURPOSE OF AWARD** The Commerce Bank Presidential Award for Distinguished Services to Student Belonging was established in the spring of 1978 to recognize outstanding individual contributions to the development and quality education of all students, including those from low-income or first-generation backgrounds at Kansas State University.

**ELIGIBILITY** The award is based upon any contributions completed prior to **June 30, 2025**. A nominee may be a faculty or staff member, an alumnus, or friend of the University, and may be someone previously nominated, but not awarded in the past.

**NATURE OF AWARD** The award will be made at a special reception on **Tuesday, January 27, 2026** during the University's Martin Luther King, Jr. Observance Week. The recipient will receive a plaque and monetary award.

**CRITERIA FOR NOMINATION** Nomination criteria include one or more of the following:

1. Outstanding teaching in cultural courses or in disciplines where material pertinent to fostering a culture of belonging for all students, including historically under-represented students has been integrated effectively.
2. Outstanding contributions in developing an educational program promoting a sense of belonging for students or the campus community, which contributes to the well-being of student belonging or a positive climate for all students overall.
3. Outstanding efforts in recruiting students from low-income, first-generation, or other unique backgrounds.
4. Outstanding efforts to retain and develop from low-income, first-generation, or other unique backgrounds students.
5. Unique and highly impactful efforts, research, or study abroad programs directed toward low-income, first-generation, or other unique backgrounds.

**APPLICATIONS** Faculty, staff and alumni members who are eligible for this award can only be nominated by KSU faculty, students, staff, or administrators. The deadline date for completed applications/nominations is **5:00 p.m. on Friday, October 31st, 2025**.
