The recruitment cycle for undergraduate and graduate programs actually begins 8-15 months prior to the semester starting. Most admission decisions and registration processes have occurred or are in the final decisions weeks before the semester start. If the next available semester is being chosen you will be required to work with UG or GR Admissions on a transition plan for ALL new admits.

When is the Final Term the Program Will Be Offered or a Degree Can be conferred:*

Baccalaureate and master's programs can be phased out over a maximum of five academic years. A five-year phase-out would allow for any new admits (aka Freshmen) to finish out the degree they were just admitted to Doctoral programs can be phased out over a maximum of six academic years.
