



## College Transfer Program Scholarship

DMSA & Cargill have partnered to build a college-going intent in Southwest Kansas, where the majority of the population are first-generation racial/ethnic minorities living in at-risk communities. The transfer College-for-a-Day institute is a core program component accompanied by a scholarship for financial support to increase retention and graduation for students.

Interested applicants should meet the following requirements;

**Either:**

- A High School Senior enrolling at Dodge City Community College, or
- A Sophomore of Dodge City Community College transferring to K-State.
  - Enrolled within the College of Agriculture, Business, or Engineering

**With Preference To:**

- Dependents or children of a Cargill Employee

Scholarship recipients are eligible for up to **\$1,000/yr** while attending DC3 and **\$2,000/yr** while attending K-State. Scholarship amounts are dependent on GPA and are renewable once per institution.
