## **ORDINANCE NO. 9553**

AN ORDINANCE OF THE CITY OF LAWRENCE, KANSAS, AMENDING ORDINANCE NO. 9388, INCREASING THE BUDGET OF THE CITY OF LAWRENCE, KANSAS, FOR THE GENERAL FUND, LIBRARY FUND, CAPITAL IMPROVEMENT, 9NH SOUTH, 9NH NORTH, 720 LLC NRA, CITY PARKS MEMORIAL, HOUSING TRUST FUND FOR THE CALENDAR YEAR COMMENCING JANUARY 1, 2018.

**WHEREAS**, the Governing Body of the City of Lawrence, Kansas, desires to amend the 2018 City Budget to the increase the budget for the General Fund, Library Fund, Capital Improvement, 9NH South, 9NH North, 720 LLC NRA, City Parks Memorial, Housing Trust Fund in order to increase expenditure authority from cash carried forward and unanticipated revenue;

**WHEREAS**, the Governing Body caused to be published on the 20<sup>th</sup> day of July, 2018, in accordance with K.S.A. 79-2929a, as amended, in the Lawrence Journal-World, a daily newspaper of general circulation within Douglas County, Kansas, notice of a public hearing to be conducted on August 7, 2018, at 5:45 o'clock p.m., or as soon thereafter as the matter could be heard, at the City Commission Chambers, City Hall, Lawrence, Kansas, for the purpose of answering and hearing objections of taxpayers relating to the 2018 Amended City Budget; and

**WHEREAS**, such public hearing was held at the time and place designated for the purposes stated, all as provided in the published notice of said hearing.

## NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:

**SECTION 1.** The above-stated recitals are incorporated herein by reference and are made a part of this ordinance as if set forth in full.

**SECTION 2**. Ordinance No. 9388, adopting the 2018 City Budget, is hereby amended to increase the General Fund budget to \$93,603,000, Library Fund budget to \$4,268,000, the Capital Improvement Reserve Fund budget to \$9,689,000, the 9 NH South Fund budget to \$609,000, the 9 NH North Fund budget to \$268,000, 720 LLC NRA Fund budget to \$15,000, City Parks Memorial Fund budget to \$113,000, and the Housing Trust Fund budget to \$803,000.
