GENERAL CLASSROOM INFORMATION

1. Classrooms are not assigned to any specific academic department. They are administered and maintained by the Division of Facilities.
2. Classrooms are used for semester courses based on department location, class size and equipment needs. They are scheduled each semester by the Registrar.
3. Scheduled classes have priority of technology classrooms. To utilize the space for other purposes and requests should be made to facilities room scheduling via the online form. <http://www.k-state.edu/facilities/RequestBuilding.pdf>
4. Seating Capacity may include ADA tables. Rooms under 50 capacities will have 2 chairs. Rooms over 50 will have table space for 4 wheelchairs.
5. The Union Wildcat Chamber (UN101) will be available for classes on Monday through Friday from 8:30 to 12:20. The room is not available for summer classes.

TECHNOLOGY CLASSROOMS :

1. * Basic Technology classrooms are equipped with a place to plug a laptop and LCD projector or other display. Video, internet (may be wireless) and audio connections are provided.
2. ** Common Technology classrooms are equipped with an LCD projector or other display, computer (with DVD drive), sound system, document camera and internet connection.
3. *** Expanded Technology classrooms include common technology equipment which have additional capabilities that may include video conferencing equipment and/or video or audio capturing equipment.
4. ^ Studio Technology Classrooms have computer stations and are equipped with hardware and software that are unique to a discipline or related disciplines.

UNDER UTILIZATION: Under utilization of the room's capacity may result in the relocation of a class to accommodate larger classes.

FIRE CODE: Each general use classroom will remain in compliance with fire and safety regulations. Scheduling classes for each classroom will not exceed the designated seating capacity of the room. Facilities Scheduling will relocate classes exceeding the designated capacities. Rescheduling of classes will not be permitted after the 20th day of classes.

ADDITIONAL SEATING: due to the fire code, additional chairs should not be brought into any centrally scheduled classrooms. If the movable seating is inadequate, contact Facilities Scheduling office at 532-1712.
