GENERAL CLASSROOM INFORMATION

1. Classrooms are not assigned to any specific academic department. They are administered and maintained by the Division of Facilities.
2. Classrooms are used for semester courses based on department location, class size and equipment needs. They are scheduled each semester by the Registrar.
3. Scheduled classes have priority of technology classrooms. To utilize the space for other purposes, requests should be made to facilities room scheduling via the online form. [Building and Grounds Request Form](#)
4. Seating Capacity may include ADA tables.
5. The Union Wildcat Chamber (UN101) will be available for classes on Monday through Friday from 8:30 to 12:20. The room is not available for summer classes.

TECHNOLOGY CLASSROOMS :

1. * Basic Technology classrooms are equipped with a projector, computer(with a DVD drive), camera, and microphone for Zoom video conferencing. All cabling in place is dedicated to the in-room computer. If the use of a personal laptop is preferred, the user will need to provide a video cable and any adapters needed for the laptop connection, or use the wireless screen share function in Zoom.
2. ** Common Technology classrooms include all equipment found in Basic Technology classrooms, plus the addition of a document camera.
3. *** Expanded Technology classrooms include all equipment found in Common Technology classrooms, plus one or more of the following additional capabilities: PTZ video cameras, video or audio capturing equipment, or enhanced interactive technologies.
4. ^ Studio Technology Classrooms have computer stations and are equipped with hardware and software that are unique to a discipline or related disciplines.

UNDER UTILIZATION: Under utilization of the room's capacity may result in the relocation of a class to accommodate larger classes.

FIRE CODE: Each general use classroom will remain in compliance with fire and safety regulations. Scheduling classes for each classroom will not exceed the designated seating capacity of the room. Classes exceeding the designated capacities will be relocated. Rescheduling of classes will not be permitted after the 20th day of classes.

ADDITIONAL SEATING: due to the fire code, additional chairs should not be brought into any centrally scheduled classrooms. If the movable seating is inadequate, contact Facilities Customer Service at 532-6389.
