I. Call to Order

The meeting was called to order by Tom Herald, Chair, at 3:34 p.m.

II. Distinguished Lecturers Proposal-Larry Rodgers

Larry Rodgers presented information on a distinguished lecturers series that would be similar to the Landon Lecturers but instead of being of a political nature, theses lectures would be more intellectual. He thought the idea would work better if it is more student driven rather than administrative/faculty driven. Rodgers had gotten a good response from the Provost's Office. He would like to turn it into an academic enterprise. The concept would be that a faculty member would act as a host to the lecturer for 2 -3 days and the lecturer would do seminars during the day and a lecture at night. These activities would count as credit hours on a student's transcript. The student may write a reflective paper that he would send to the lecturer to receive the credit.

Rodgers said the project would be funded by the Provost's Office permanently as it is an endowment fund from Foundation. A permanent part-time administrator would be needed for the program. Tuition would be generated and it would be an honor for students to participate in the program. They would read in preparation for the seminars and go away with a good experience. Rodgers said he would like to see K-State run one lecture the first years for \$20,000. Hopper said this sounded like a good idea that students would endorse. Rodgers said they would like students to be involved in the selection process for the lecturers.

The committee discussed where the credits could be offered - through individual colleges or under some general heading. Rodgers said he was proposing that 8 - 12 students be allowed to participate for each program. It is not an honors experience, but rather an elite academic experience. There was discussion about whether twelve students was too limited as that figures out to be about one per college. Rodgers said students apply and get selected and the ones not chosen would go on a waiting list for the next lecturers. Rodgers said that he would like to see the lecture series start as a pilot and get a high visibility speaker and see how it works.

Hopper announced that this was the last Academic Affairs meeting he would be serving as the student representative. At the next Faculty Senate meeting, he will introduce the new Student Body President, Student Senate Chair, and Academic Affairs representative. Selfridge said he wanted to commend the college representatives and student representatives on Faculty Senate for their good work this year.
