V. Old Business

A. Course and Curriculum Changes

1. On-line form filler - John Selfridge

Selfridge reported that no decisions will be made about the on-line form filler for course and curriculum changes until the portal software has been chosen for the university. He said that in the mean time, work can be done on making the paper version better and make it easier to convert to online. The on-line form filler will not be ready until next fall.

B. Academic definitions

Spears said that she has not had a chance to work on the academic definitions yet.

C. Exams Scheduled Outside of Regular Class Times

Spears reported that she met with CAPP last week and they have accepted our amendment. This item as amended will appear on the January agenda for Faculty Senate.

D. Semester Final Examinations

Spears said that this item was discussed at CAPP but they were not ready to move forward on it. CAPP would like to have another month to work on this issue. Spears said she provided them with a template that should minimize confusion when the policy is brought forward to Faculty Senate.

E. Credit hour requirements for graduating with honors

Spears reported that CAPP referred this issue to a subcommittee. CAPP was not opposed to changing the credit hour requirement for graduating with honors in theory, but they did feel that it put students who started their college careers at KSU at a disadvantage. They also want to reexamine the definitions of summa cum laude, magna cum laude, and cum laude degrees because relatively few students now graduate with magna cum laude.

F. Plus/Minus System

CAPP said they have looked at the plus/minus system in the past, but will look at this issue again. The last time this issue came up, faculty could not agree with what students wanted.

G. Secondary Majors and Minors

Spears said that these issues would be reexamined by CAPP. The subcommittee has agreed to contact those secondary major programs who favor a change in policy (Leadership Studies, Gerontology, and Natural Resources and Environmental Studies) as well as develop a more comprehensive list of the academic policy issues involved.

H. Line Schedule Issues

Spears reported that this issue was also referred to CAPP. The last few line schedules have not shown cross listings and they didn't realize that some programs rely on the line schedule for recruiting purposes.

VI. New Business

A. A motion was made by Herald and seconded by Selfridge to approve additions to the May 2001 Graduation List. Motion passed.

B. Improving the format for handling Course and Curriculum/Policy Changes
Selfridge suggested that Academic Affairs members compile a list of frequently asked questions faculty have
about handling course and curriculum changes. Spears said that members could send this information to her.
There was also discussion about common practices that may not be formalized as policy. Academic Affairs
could compile a list of such practices. Spears reported that policies were green and white sheeted in the past
and it might be a good idea to go back to that. She said she would talk to department heads and course and
curriculum chairs to get their input. Spears said she would take the idea of frequently asked questions and
green and white sheeting policy changes to the Faculty Senate Leadership Committee.
