The meeting was called to order by Jackie Spears, Chair, at 3:35 p.m.

- A. Course and Curriculum Changes
  - 1. On-line form filler/paper format John Selfridge Selfridge reported that people are being hired to assist with the on-line form filler.

- B. Academic definitions no report
- C. Exams Scheduled Outside of Regular Class Times/Extended Uniform Class Time Spears reported that the extended uniform class times proposal was discussed at the last CAPP meeting and it was tabled and will be discussed at their next meeting. This issue primarily deals with graduate classes. Departments that teach graduate level courses offer them at times that meet the needs of their students. If they were forced to teach them at specific times, they would lose part of their market. Undergraduate classes are large enough and compete for space so a common format is needed between 7:30 a.m. and 10:30 p.m.

- E. Credit hour requirements for graduating with honors Spears reported that CAPP has not appointed a subcommittee to look into this issue.
- F. Secondary Majors and Minors
  Spears reported that three faculty who deal with secondary majors and minors made presentations at the last
  CAPP meeting. CAPP agreed to treat secondary majors the same as majors and allow students to stay longer
  to complete secondary majors after they have finished their major. This rule will not apply to minors.
- G. Line Schedule Issues

  Spears said that this issue is regarding the cross-referencing of courses that count for secondary majors and minor. This issue will not be addressed until the exam schedule and class day schedule resolved first.
- H. Report from the Advising Enhancement Task Force Spears reported that the Advising Enhancement Task Force Report was due out at the end of March but she has not seen it yet. She will contact Mike Lynch to discuss this.
- I. UGE Assessment
  Spears reported that Ron Downey, Planning and Analysis, asked that Academic Affairs report: (1) whether
  they accept and concur with the committee's findings, (2) if and/or how to modify the current assessment
  plan, and (3) additional faculty members who could be appointed to the Portfolio Assessment Committee.
  With regard to the first issue, the committee accepts and concurs with the committee's findings. Academic
  Affairs members felt that the current assessment process does not work well, however, and were not sure how
  to improve it.

Considerable discussion ensued as committee members struggled with how to assess a skill, such as writing, that is affected by more than the UGE experience and that is not necessarily characterized consistently across UGE courses. Several suggestions were made. One was that a sample of students be tracked across their undergraduate experience. A second was that faculty in the College of Education be sought out to examine the issue. A third was that the focus of the assessment be shifted from an analysis of writing skills to a self-report of the impact of UGE courses.

Spears asked Pesci to solicit the UGE Council response to some of the suggestions. She will talk to Ron Downey prior to the next Academic Affairs meeting. A motion was made by Herald and seconded by Haddock to table the UGE asseessment issue. Motion passed.

Pesci reported that the General Education Council will meet on Thursday and will be looking at two courses to approve for general education.

B. Haddock report on University Library Committee

Haddock reported that the University Library Committee has met twice since the last Academic Affairs meeting and he also received minutes from the one he was unable to attend. On March 4<sup>th</sup>, Dean Hobrock gave a preliminary budget report for the library and also discussed ARL membership. On March 25<sup>th</sup>, the Provost met with the University Library Committee to discuss budget cuts. The library may face a 2 ½ % budget cut which will come out of the monographs budget. On April 1<sup>st</sup>, Karin Westman and Naomi Wood (English department faculty) discussed results from a technology survey they conducted. They reported that out of 686 students in English classes, 62% use an Internet search engine to get information for papers they write. Academic Affairs may want to look into the quality of information students are getting for papers and also plagiarism.
