Questions regarding the basic need and purpose for the program were answered by Fred Guzek, Technology and Aviation faculty member. A lengthy discussion took place regarding elective courses. An editorial change was made to the proposal to include other courses approved in the electives section. Also touched on was a question about scholarship work for graduate faculty and students. ## 4. Reports

## A. CAPP (Committee on Academic Policies and Procedures)

Nielsen reported that CAPP met last week. A few non-standard courses were approved and other questions regarding textbook reporting status were answered. There was discussion surrounding the stand alone minor. A subcommittee was appointed (Kevin Lease, Larry Satzler, and Monty Nielsen) to review issues that need to be resolved in implementation of the stand alone minor. Jeff Hornsby volunteered to assist on this committee. Nielsen suggested Hornsby contact Anand Desai, who will be chairing CAPP this upcoming year.

# B. iSIS Steering Committee

Nielsen reported that Lynn Carlin reviewed the status of various projects, including K-State 8, academic advising, and other projects that are being worked on. The new tool for iSIS was demonstrated for committee members. Hornsby commented on grade submission using iSIS. He noted it takes the faculty member or person entering the grades in an infinite loop, even after they complete what they are asked to do. Other committee members voiced the same concern and it was suggested by several committee members that the message in iSIS needs to desist from indicating the person needs to take action when they have already done so. Nielsen will take their comments back to the steering committee.

#### 5. Old Business

## A. K-State 8 Course Tagging –

Vicki Clegg was in attendance. After the April 20<sup>th</sup> Academic Affairs meeting, she requested department heads to review tagged courses to determine whether or not their students would be able to fulfill the K-State 8 requirements with the courses that had been tagged. On April 21<sup>st</sup> a message was sent out to departments and several reminders were sent thereafter. Forty-six out of 56 responded. Out of the 46, all believed there were enough courses. There were comments from a few departments that advising would need to be more intense in order to make certain students are aware of what they need to do to fulfill the requirements in certain programs.

Easton commented on the program and courses that were tagged. He had a concern that this will fundamentally change the way classes are taken at K-State. Also, he discussed assessment and concern about all courses needing to have an assessment piece for each.... Clegg interjected that assessing will not be done within each and every course offered, but rather for the program as a whole. This was a relief to some members.

In discussion of the courses tagged, Clegg commented that departments themselves were the responsible groups in charge of determining the tagging on courses. She stated that trust was extended to departments in this process and it was the strong desire of the task force to handle the process in this manner.

During discussion, some committee members felt persons in the university would simply take the path of least resistance in advising students what to take and students as well may fulfill the requirements without too much thought and consideration given to their overall education. Clegg noted that individuals who are already trying to take the path of least resistance are still going to do this. However, those who are truly interested in the best interest of the university and students will give the time and attention to this that it deserves.

Lengthy discussion ensued regarding assessment of the program. The assessment piece *is* being worked on by a committee. Comments were given regarding taking the two items separately; tagging and assessment. There was continued discussion about what kind of assessment we're talking about.

It seems that assessment must be completed and acceptable prior to going forward with the implementation process.

After much discussion, the Academic Affairs committee felt action was necessary from this committee.

Bennett moved for a resolution to be made: Be it resolved that it is the sense of the committee that the K-State 8 tagging procedures, as outlined, will be approved, once an acceptable outline of an assessment procedure plan is provided. Zajac seconded the motion. Motion carried.

B. College of Arts and Sciences, African Studies – New certificate and minor program King reported this program will not be voted on at this time as there are still unanswered questions regarding courses being used in part of assessment and whether those departments have given their approval.

## 6. New Business

- A. Catalog designations for semester offerings (springs, summer, and fall)

  After brief discussion, it was realized this was more of an administrative issue about how to submit multiple course changes having to do with semester change. Ms. Becker assisted in addressing what needed to be done and will contact those involved.
