# 5. Reports

- A. CAPP Kelli was not able to attend today but she sent out a brief report via email regarding items discussed at last week's CAPP meeting including progress on the stand alone minor, or what will now be referred to as Post Baccalaureate Minor and K-State 8.
- B. iSIS Task Force

Moser reported that almost the entire meeting was devoted to going through the "list". Committee members checked off approximately 50 things. This means they have 1) already accomplished the tasked, 2) are working on it, or 3) will be working on it. Occasionally they elect not to work on a list item, but this is rare.

# 6. Old Business

A. New minor in Aerospace Studies - Update

Moser met with Lt. Col Meyer regarding the minor once more after the last Academic Affairs meeting. The department agreed to drop AERO 099 and AERO 215, as well as AERO 499 from the proposed Aerospace studies minor. All courses remaining in the minor would be open to all K-State students. Moser asked if there was any further discussion regarding the minor. Zajac moved for approval of the revised program, seconded by Roberts. Motion carried.

B. Meeting with students regarding K-State 8

Moser unexpectedly was unable to attend the meeting with the students and Vicki; however David Sachs attended on his behalf. Moser deferred to Oliver to report on the meeting. She began by noting there was quite a bit of miscommunication last year about process and students felt confused about the proposal. She now believes students are on the same page and the legislation that had been written previously by Student Senate last year has been addressed. Clegg was a key element in providing historical detail on the program. She willingly offered to visit student senate if needed to provide that same background to current students if needed. Oliver commented there will most likely be some kind of action on the record to indicate that Student Senate does support the K-State 8.

C. Honorary Degree Procedures

As announced at the Faculty Senate meeting, the Honorary Degree Procedures proposal was withdrawn from the agenda. This was due to the fact that it was in violation of Faculty Senate constitution. The constitution states that senate must approve all honorary degree candidates. It would take amending the FS constitution to change that current policy. A recommendation from a faculty senator was that the committee (as outlined in proposal) work in the framework of the procedures, but then bring its recommendation forward to the senate body for approval. Moser will be talking with President Schulz about this recommendation and others from senators; however he requested input from committee members. Bennett provided a little background about the A&S caucus meeting where the inconsistency was discovered. Discussion ensued about pros and cons of having Faculty Senate vote on candidates. DeRouchey commented that at some point you need to trust the people on the committee that are recommending a candidate. Another thought was maybe Faculty Senate could delegate the decision to the committee members versus having a vote on the floor of a senate meeting. Spears mentioned perhaps, as a suggestion, the committee could bring the name forward, but then the senate would go into an executive session to make a decision. Academic Affairs members were not sure if that was possible. Hornsby weighed in that it seems the president needs informed of the risks of both ways of handling the process. Various other comments were made by committee members. As an informational item, Moser noted that Baillargeon has done some research and sent him a list of those who had received honorary degrees from K-State.

### D. Other updates

Moser reported that at the Oct. 19 Academic Affairs meeting, the rationale for changes to the Jazz minor was noted as being somewhat vague and a committee requested that perhaps they provide a more concrete reason in future. Moser discussed this with the department, to which they provided an ample rationale for the changes. Anyone interested is welcome to see the update rationale.

Moser also reported that he contacted the UGE Council Chair, department head of English and Modern Languages regarding the course that had been approved by UGE, but its cross referenced course is not designated as UGE. He is awaiting a response, but will keep committee members informed.
