CURRICULUM CHANGE

Department of Apparel, Textiles, and Interior Design

Changes to the Interior Design B.S.

RATIONALE: The change substitutes a new department-level course to meet a K-State 8 requirement. As a result, the number of required humanities credits is reduced from 9 credit

hours to 6 credit hours and the number of professional studies credits is increased to 84 credit hours from 81 credit hours.

- D. Curriculog Implementation Committee
 - Curriculog demonstration and complete overview Charlotte Pfaff (1 Hour)

Associate Registrar, Charlotte Pfaff, provided an in-depth overview of Curriculog to committee members. She demonstrated how to use various features of the system including creating course proposals forms, reviewing agendas and impact reports, and tracking the status of a proposal. The system will go live on February 1st for course proposals only by the pilot colleges. The curriculum proposal work flow process is more complex and is not ready to go live yet. Training will be provided in various manners as the system rolls out. It was asked who will be originators for proposals. This is still a matter of discussion. However, the decision about how to handle this may be made by each college. In the beginning, some colleges may decide to have key persons enter the information; whereas others may decide to provide training to their faculty on an individual level so that they can enter the proposal.

Hartman reminded committee members that as the transition begins in February this committee will be reviewing courses proposals both via Curriculog and the current method.

8. Announcements/for the good of the University

Hartman reported that the Interdisciplinary work group is coming close to completion of their work and the proposed changes will be brought forward to this committee for approval in the near future.
