With strategic planning, students can take a course that meets both the overlay and a degree course and/or K-State 8 course requirement; so, students may not be required to take an additional course. ### 4. Chair / Co-Chairs for Academic Affairs 2017-2018

Bormann and Hartman extended the opportunity to others who would like to care for this role. However, both Hartman and Bormann are willing to continue as co-chairs. Consensus of the body was to have them continue in this role and they are grateful to both for their leadership.

## 5. Unfinished Business:

#### A. Retake Policy

Bormann will coordinate directly with CAPP Chair Alison Wheatley and KSIS Taskforce Chair Karen Pence to communicate Faculty Senate Academic Affairs Committee (AAC) members' concerns about inconsistent application of the retake policy. AAC would like to ensure that how we calculate GPA is in-keeping with the intentions of the policy. They would like to charge CAPP with the task of revising that policy to ensure GPA calculations are consistent and fairly represent every student's academic progress.

# 6. Committee reports:

A. Committee on Academic Policy and Procedures – Reinert

The CAPP sub-committee continues to refine the changes to the Incomplete Policy. The committee is considering feedback and concerns regarding how to define "passing at the time of the request", likely by removing that requirement from the proposed changes. Once the policy changes are approved by CAPP, the proposal will come to AAC for review and approval.

The new K-State 360 system is now live. With K-State 360, we can track co-curricular involvement and engagement. K-State 360 is built on the Talisma CRM data system.

CAPP continues to learn about how changes to the policies and procedures for advance credit will impact student transcripts. K-State was the only KBOR institution that was noting a grade on the transcript for advance credit. We will no longer be including the advance credit grade in the GPA or transcript. Some courses require a certain grade for prerequisites that are impacted by this policy change; so, a number of expedited course changes will need to be processed to update our undergraduate catalog. The Registrar's Office and Undergraduate Admissions are working with colleges that are impacted.

#### B. KSIS – Reinert

The College of Agriculture has requested that more detail be added to the student summary statistics in the academics tab in KSIS in order to show a breakdown of credits: 1) units taken at K-State, 2) units taken at 2-year institution, 3) units taken at 4-year transfer institution, 4) units from AP, IB, CLEP.

Course details are not always the same in the KSIS catalog and Acalog. The Registrar's Office is working on trying to get the systems data to match. The KSIS catalog tends to be out-of-date and also reflects information based on effective dates. When students look at course details in KSIS, they are viewing the details in the KSIS catalog. Acalog is the official catalog record.

C. University Library Committee – Bormann Nothing to report.

# D. Curriculog Implementation Committee

Pilot colleges are successfully using Curriculog to submit course change and addition proposals. Training has been expanded to all University employees, in addition to the pilot colleges. Walk-ins are welcome for the training sessions.
