5. Co-Chairs for Academic Affairs 2018-2019

Bormann and Easton were elected as co-chairs for the 2018-2019 year. Committee members offered their thanks to Teresa Hartman for her dedicated leadership and service as chair and co-chair for these past three years.

6. Committee Reports

A. ARPS (Academic Records, Processes and Systems Committee)

This is the newly renamed KSIS taskforce. Hartman reported the username field was discussed in KSIS, related to preferred name vs. legal name and how to handle issues that arise from that. There was also discussion regarding when a student's last name changes. Another topic was the GDPR (General Data Protection Regulation – European privacy law). The General Counsel's office is working

with a few other regents' universities to share the cost of getting outside advice/counsel on the implementation of required changes.

B. CAPP (Committee on Academic Policy and Procedure)
No report.

C. University Library Committee No report.

D. Curriculog

The committee is discussing a new name, as they are no longer the implementation committee. The members agree their meeting monthly is appropriate to discuss possible changes to process and procedure, to answer questions that arise, and to review updates in the software, and the like. They will not meet during the month of June due to orientation and enrollment. There will be down time during July 1-15 to allow for updates to the forms and to begin requesting updates to committee members from the colleges. A new form will be created over the summer to process minor changes that do not need college course and curriculum or faculty senate approval, such as an change in semester offering, if that is the *only* thing changing in a course or if there is a typographical error *only*, such as a word spelled incorrectly. A CIP code change form will also be created; which allows a college to request a change to a program. These requests do not come to FS Academic Affairs for approval. Brian Niehoff briefly discussed what a CIP code is and why they are important.

7. Committee assignments

A. CAPP

CAPP meets the second Wednesday of the month at 10:30 am. Don Von Bergen volunteered to serve.

- B. Part of CAPP: Academic Records, Processes and Systems Committee (ARPS) *Previously KSIS* Amy Hageman volunteered to serve.
- C. University Library Committee

Amanda McDiffett volunteered to serve. There was discussion over the value of continuing to have an AAC member as a representative on the committee or whether a report can be given to AAC once or twice a year. McDiffett will attend and report back.

8. Ongoing Business

A. K-State 8 tag review

K-State 8 began in 2011 and a review of tags began a few years later. AAC has been discussing the process for tag review this year and will continue this conversation in the fall. The K-State 8 Council is still in place, but the chair, Steve Dandaneau, will be leaving the university in June. Bormann, Easton, and Hartman created a possible process for handling tags that have been reviewed by the K-State 8 Council and are deemed to no longer fit the course, but the department does not agree with the assessment. That document still needs to be reviewed by the K-State 8 Council before being presented to AAC.

- B. Updates to Approval, Routing, and Notification procedures for Course and Curriculum changes The procedures manual needs reviewed and updated to bring it in line with the changes that have occurred in the last two years. Bormann, Easton, and Candace will begin work on this over the summer.
- 9. Announcements/for the good of the University

There was brief discussion about the consensual romantic relationship PPM chapter that passed Faculty Senate on May 8th.
