The Education courses were approved during the discussion of the new EdD in College Community Leadership. See #5 below.

A motion was made by Easton and seconded by Douthit to approve the AG courses. Discussion: AGED 798 should probably have a pre-req of 797. There will be communication sent to the department regarding this request. AGED 620 – there was discussion about the tag. After discussion it was the consensus that AGED 620 and AGED 790 should move forward, but AGED 797-799 need further conversation.

Easton moved to table AGED 797-799, seconded by Von Bergen. Motion carried. Motion carried to approve AGED 620 and AGED 790.

A motion was made by Easton and seconded by Tanona to approve the AS courses.

Discussion: Question on the photography courses. ART 627 seems to need a prerequisite since this course seems tied to another. ART 652 – recommended removing "graduating students" wording from description. There were questions related to some of the MC courses, specifically 683, regarding the tags and rationale. It was agreed the MC courses should be acted on all together once a response is received or a guest is present.

Easton moved and it was seconded to table ART 627, ART 652 and all MC courses. Motion carried. Motion carried to approve all of the other AS course proposals.

A motion was made by Easton and seconded by Tanona to approve the Business and Engineering courses. Discussion: There was a brief question on the CC courses. There was confirmation of response from Polytechnic on those courses, that response will be uploaded in Curriculog. CIS 115 was briefly asked about as well. It was verified the impact report copied in the system was in error.

#### Motion carried.

A motion was made by Easton and seconded by Tanona to approve the HHS and Vet Med courses. Discussion: There were questions on several of the courses. It was inquired if FNDH 311 was still desired since the BS in Public Health did not move forward. Since it was noted some of the courses will be coming back for approval independent of the degree, it was decided this proposal should be moved forward. However, it was recommended the first sentence in the course description be deleted that refers to lecture, 3 days a week. It was also recommended that the word "lecture" be removed from the course description in the other FNDH courses as well. FNDH 897 appeared to have an extra word at the end of the course title, which will be removed. These friendly amendments will be made and verified with the unit. It was noted that KIN 840 is part of a cross-listed course that was put through last year (MPH 840). All the other courses are being submitted, as requested by this body last year, so they can flow together. Two of the other courses are in process in Curriculog and all five will be acted on together at FS when ready.

Motion carried with friendly amendments.

## 5. New Curriculum proposal

A motion was made by Easton and seconded by Von Bergen to approve the new EdD degree and associated courses. David Thompson and Jerry Johnson were present to give the background on this proposal and answer questions. The program itself has been around for more than three decades; however, it was offered in a different location. The Center accompanies the program and Dr. Roueche has been hired by the University. This is a program that goes throughout the nation. Our faculty in adult learning and leadership are qualified to teach it. The courses have been completely re-written from what they were and this will indeed be a K-State degree with K-State courses. The program has been proven to be able to place its graduates upon completion. Resource information was provided as well.

Discussion: Several courses were questioned because no prerequisites were listed for ones that seem to be second in sequence. It was responded that the courses are in a lock-step curriculum and are taken one after the other in sequence. However, those can be amended as needed in the requisites section. The department was agreeable to those changes. Either a requisite will be entered or note that these courses are only for students in the EdD Community College Leadership degree. The choice of "on sufficient demand" instead of a specific semester offering was also inquired about. It was noted that the cohorts who participate in the program are generally large, but capped at 30. Students for this program and the courses are recruited specifically. The usually these come from one cohort, a community college. The demand is driven by the community colleges, not the other way around. When sufficient demand is in place, the program will be taught. It was reported that students cannot enter the program in the middle. They begin with EDACE 851 and go all the way through. This program is similar to how they administer their MS program. It was recommended the courses should be linked as either prerequisites or corequisites. This way a student unfamiliar with the program won't be under the impression they can enroll. There were questions about the leadership for the program. There's a succession plan in place, so to speak, and therefore, the program will continue to have success not dependent on any one person.

It was asked if this will negatively affect their other program enrollments. The audiences are completely different so this will not detract from their other degrees. The center itself is here, it was approved by the KBOR a few months back. Dr. Roueche is now telecommuting for all purposes. Detailed discussion was held about the history of the program and the like. Clarifying language will be included in the proposal and rationale to highlight that this is our program now. Easton will work with Johnson to finalize the documentation.

A suggestion was made to remove the word "daily" from the course description for EDACE 931. This was agreed upon.

Motion carried with one opposed. As a side note, the courses will be voted on separately and not be tied together in one motion with the degree. This is the typical process.

A motion was made by Easton and seconded by Von Bergen to approve these requests. Motion carried.

#### 9. Ongoing Business – Updates

- A. Proposed revision to University Handbook, Section F103 transfer students (see email attachment) Easton provided an update on this item. This proposal was approved by AAC and sent to Exec, but was sent back. However, after discussion between various parties, the original proposal will move forward to next steps and then further changes to that policy will be reviewed later down the road. Implementation, if approved by Faculty Senate in December, would be for Fall 2020.
- B. Graduating with Research
  No update on this, but there is still interest if it is rigorous enough. Currently there's a certificate
  being provided students when they get involved. It's great to get students involved; however, it was

the consensus that having two different layers is not significant enough and that one path would be better received. Easton will report this feedback to Marshall for any future work on a proposal.

- C. University-wide concurrent Bachelors and Masters degrees This university-wide proposal is on hold until the new Registrar is in place and it can be researched. This will come back to committee for discussion later on. At this time, if units have proposals for concurrent degrees, they are welcome to submit them through the standard approval process.
- D. Approval, Routing, and Notification procedures for Course and Curriculum changes

  Due to the overwhelming amount of curricular work this semester, the document has not been
  worked on recently. The plan will be to review it and discuss it in January.

#### 10. Committee Reports and Curriculog updates

- A. ARPS (Academic Records, Processes and Systems Committee) \*Need a new representative. Easton will attend for the time being.
- B. CAPP (Committee on Academic Policy and Procedure) Almes No report.

### 11. Announcements/for the good of the University

- A. University-wide excused absence policy is being worked on. FAC is taking lead on this, but AAC will be asked to provide input. Lively discussion was had about this.
- B. Follett/Canvas. Easton reported there have been discussions between FSCOT and Follett relating to implementation of some advanced book purchasing software into Canvas. They would like to form a small working group to discuss how the book store and other text book companies interact with K-State faculty, students, and systems. FSCOT is taking lead on this, but members from AAC, FAC, and those who work with alternative textbooks proposals will be included. AAC is asked for two or three volunteers. Maseberg-Tomlinson, Tanona, and Sevin are willing to serve.
- C. Charge/purpose of FS Academic Affairs committee. Precipitating from conversation and comments made at the Faculty Senate meeting this month, the role and purpose of this committee was discussed. Consensus was communication is key related to impacts. If a proposal comes before this committee and it is determined communication hasn't happened with impacted units, we should request those occur and, if necessary, help facilitate those conversations. The sum up is this committee will do its best to put forward a viable proposal. If, at times, this committee believes sufficient discussion has occurred at this level and it needs Faculty Senate action, it will perhaps include background information to senators when that kind of a proposal is approved and is moving forward.
- D. K-State 8 tag review. Niehoff reported that the Ethical Reasoning tag has been reviewed this semester. After discussion it was agree a report will be provided to this committee outlining the results. There was some discussion of how to remove a number of tags at the same time for future. If this is the *only* change being made to the course, it may be possible to identify a bulk method route for a single prefix/department. This would limit search capabilities with archived changes in the system. Someone would need to search by prefix and not a prefix and number. Additionally, this would be an exception. The removal of the tags would still go through standard process.
- E. Online course descriptions. Niehoff raised the topic of short course descriptions for online courses. This is a topic that will likely need future discussion. It was inquired if the University is hurting itself by making descriptions shorter. A few ideas were brainstormed.
