He reported that he and Senator Kouba had asked for a distinction between the two Writing with AI proposals, one is for credit and the other is not, and that it's made clear, which they did. He mentioned he is involved in the College of Business Admin proposals so has recused himself and only Senator Kouba will be involved with those. He said the College of business had a concern about the overlap with the Finances and the Farm microcredential. He anticipates they will access impact and find a productive way forward.
