# Faculty Senate Executive Committee Monday, October 25, 2010 3:30 pm Union Room 213

1. President Cauble called the meeting to order at 3:31 p.m.

2. Approval of September 27, 2010 Executive Committee minutes
D Rintoul noted a correction needed in 3.C., last sentence of the paragraph. SPSF should be SPSS. T Vontz
moved to accept the minutes as corrected. M Ransom seconded. The minutes were approved as corrected.

- 3. Report from Standing Committees and Student Senate
  - A. Academic Affairs Committee Daniel Moser
    - K-State 8 Assessment piece (revised on 10/19/2010) Attachment 1 (and 1a) D Moser, on behalf of the Academic Affairs Committee, moved to place the K-State 8 Assessment piece on the November Faculty Senate agenda. Motion carried. President Cauble stated we had a first reading at the October Faculty Senate meeting. Depending on the number of questions and discussion, we may need a second reading, but a vote could also be taken.
    - Honorary Degree procedures **Attachment 2**Honorary Degrees initially were not allowed by the BoR; however, this has changed. President Schulz drafted a proposal for issuing honorary degrees at K-State. Academic Affairs has reviewed and revised the draft. D Moser, on behalf of the Academic Affairs Committee, moved to place the Honorary Degree Procedures document on the November Faculty Senate agenda. Discussion regarding the second and third bullets under Eligibility followed. The consensus was to change the second bullet to read "Active employees of Kansas State University are not eligible for candidacy." The third bullet was changed to read "Honorary degrees shall not be conferred on any employee associated with the University before such individual has not been employed at the University for at least five years." The motion was amended to request the edited Honorary Degree Procedures document be placed on the November Faculty Senate agenda. Motion carried.
    - Items for Faculty Senate consent agenda (Pages 2-4)
      D Moser, on behalf of the Academic Affairs Committee, moved the consent agenda be placed on the November Faculty Senate agenda. Motion carried.
    - Items for Faculty Senate discussion agenda (Page 5) **Includes Attachments 3**D Moser, on behalf of the Academic Affairs Committee, moved to have the African Studies minor and certificate program proposals, after the dates have been updated, placed on the November Faculty Senate agenda. Motion carried.

Moser expressed his appreciation to the Faculty Senate Executive Committee for its assistance with fast tracking the posthumous degree so it could be approved during the October Faculty Senate meeting.

- B. Faculty Affairs Committee Judy Hughey/Kaleen Knopp
  - Appendix G revisions Attachment 4
     J Hughey reported that Appendix G is being removed from this agenda due to continued discussions with the University General Counsel Office. Faculty Senate Leadership will be discussing appropriate action at its next meeting. Discussion included a reminder that the existing flow chart

cannot be changed without a vote in Faculty Affairs, that the Appendix G is not a new policy but an existing policy that has been re-ordered and that this policy is in Faculty Senate's domain. Additional comments included that, while it is appropriate to allow time to re-build, at some point we need to move forward with the policy so that meaningful, effective and efficient progress is made.

# C. Faculty Senate Committee on Technology – Dave Rintoul

A university attorney and Michael Wesch attended the last FSCOT meeting. iTunes U and the copyright issues relevant to it were discussed, which is a concern of the University. A copy of the contract has been requested from Apple but has not been received. The capability to view information on extramural grants online is available; however, anyone with access can view every sponsored project on campus. A Pilot study of those who are interested in this will occur after some training and participants will report back on if this is a valuable use of time and resources. Foundation accounts will not be available for viewing. Conversations with the deans should occur because there might be some trepidation regarding the open viewing access.

# D. Faculty Senate Committee on University Planning – Tom Vontz

T Vontz reported that FSCOUP met on October 21, 2010. Bruce Shubert and Casey Lauer gave a presentation on energy efficiency. KSU has entered into a \$20M contract to upgrade its infrastructure to make it more energy efficient. The University was able to acquire \$17M in low interest loans which will be invested on first priority projects, those that are certain to pay for themselves over time. Meters are being placed on buildings to track how much energy is being used in each. Creative behavior changes will be encouraged. In the near future an energy efficiency competition with KU will be announced. K-State 2025 information and themes have been received from the President's Office. FSCOUP will look closely at these over the next two weeks and draft a response to President Schulz which will be sent to him by November 5, 2010. The timeline as to when the President would be releasing the themes to the general university was discussed. A question was asked about whether K-State is looking at wind generators as an avenue for energy efficiency. This was not addressed during their meeting with Shubert and Lauer.

#### 4. Announcements

#### A. President/FSLC

Kansas Commitment and Foresight 2020, BoR plans, will be distributed to Executive Committee members. A 2.7% raise for faculty is included. There is a concern that faculty salaries will be overlooked and the Council of Faculty Senate Presidents brought this to BoR's attention. Foresight 2020 is their strategic plan; however, input from institutions was not sought which concerned university provosts. Student learning outcomes were also addressed; we are trying to align with them so we don't duplicate efforts. Research Officers of each university will be joining together to discuss the concern that BoR does not understand the research side of our missions.

# B. Caucus Chair reports

M Ransom reported that the Agriculture caucus passed a statement of support of what is being done with regard to the policies. The College of Agriculture had an unsuccessful dean's search. The College is doing well though it is in a holding pattern. E Johannes served on the search committee of 29 members. She reported that they worked hard. Seventy candidates applied, 11 were interviewed and three were brought to campus. The search committee deliberated for three hours. None of the candidates appeared to have the experience necessary to unify all aspects of the college. President Cauble stated the Provost spoke very highly of what the committee did. Ralph Richardson managed the committee and process well.

Progress is being made on establishing the search committee for the dean of Arts and Sciences. The Provost will appoint a Dean to chair the search committee.

- C. One of the three Ombudsperson submitted his resignation. Recruitment for a replacement to complete the remainder of his term will begin shortly.
