- 1. President Andrew Bennett called the meeting to order at 3:30 pm.
- 2. Informational item: New Policies and Procedure Manual (PPM) chapter Clery Act policy regarding Campus Security Authority (CSA) reporting and university timely warnings Sarah Barrett **Attachment 1**
 - Sarah Barrett spoke about a new chapter in the PPM (PPM 3110) on the Clery Act regarding Campus Security Authority (CSA). The Clery Act requires the university to report information in order to maintain a daily public crime log; any crime that occurs on campus must be published online within 24 hours. The university must ensure the rights of students who are victims of crimes. The university also must publish an annual security report that includes crime reports and security measures for the previous three years. Any violation found in the audit process would result in a \$35,000 fine.
 - A policy is needed in order to increase our compliance efforts with the Clery Act. In addition to this policy, an online training module is now required for Campus Security Authorities and there is a university wide report form.
 - CSAs are expected to report any significant crimes within 24 hours of receiving this information. Crimes that require reporting include murder and non-negligent manslaughter, negligent manslaughter, sex offenses, robbery, aggravated assault, burglary, motor vehicle theft, arson, hate crimes, domestic violence, dating violence, stalking, and arrests and referrals for disciplinary action.
 - Under the Clery Act, we do report out on crimes that occur at fraternities and sororities as these are controlled by a student organization that is officially recognized by the institution.
 - On the http://www.k-state.edu/report/ website, daily and annual security reports can be found and this is also where crimes should be reported.
 - A motion was made to place this on the Faculty Senate agenda. Motion approved.

- 4. Report from Standing Committees and Student Senate

 - B. Faculty Affairs David Lehman / Charlie Barden
 - Faculty Affairs has been reviewing the TEVAL system. There are a number of action items that the committee is still working on, including (a) educating faculty about TEVAL system best practices,

(b) educating students on how to effectively provide comments in the TEVAL system, (c) educating faculty on how to use the IDEA evaluation system, and (d) potentially adding a question regarding the instructor's effectiveness in creating an inclusive classroom environment.

C. Professional Staff Affairs – Loleta Sump / Mary Anne Andrews

- Total Rewards letters are supposed to go out to USS and Professional Staff this Friday. At the previous PSA meeting they discussed whether or not comments submitted to HCS regarding job titles were acted upon and implemented into the revised job titles. There were mixed responses as some thought their concerns were addressed and some did not think their comments were reflected in the revisions. Deans and Vice Presidents were provided information regarding job titles and information a few weeks ago and they were to distribute to the supervisors under their purview. Some supervisors have not yet received this information.
- University General Caucus and PSA developed a survey that was sent out to professional staff, which included open-ended questions regarding general concerns and the type of evaluation system professional staff would like to have. This survey was sent to over 1600 individuals and they have received over 400 responses. The next action step is to analyze the data collected through this survey.

D. Student Senate – Jack Ayres

- There are two more senate meetings in this term. The new senators will begin meeting beginning on April 13th.
- The Speaker and Speaker Pro Tempore will be selected on April 20th and cabinet and legislative positions that following weekend.
- The Tuition and Fees Strategies Committee is hearing the last fee increase proposal tonight. The committee will then discuss all the proposals for fees and tuition increases at an April meeting.

- C. Topic for discussion with Provost Mason at April 11 FS meeting
 - A few ideas were suggested for Provost Mason to discuss, but it was determined that we will have
 a great deal of discussion regarding the Clery Act. We will inform Provost Mason that Sarah Barrett
 will be in attendance to discuss the Clery Act and CSAs, and the Provost is welcome to attend as
 well if she would like.
- D. Report on March 15 Kansas Board of Regents meeting
 - The proposal for "contractual market-based education" was approved by the Board of Regents. There is so far no proposal for offering 1/2 credit classes.

- KU Med proposed making changes to the current system in order to allow for multi-year, rolling contracts in order to aide them in being awarded extramural funds. This may relate to the non-tenure track faculty at K-State as there is currently an option to make those appointments regularized that are reappointed every year or multi-year contract term employees. There are departments that would like to have multi-year contracts for regular employees. This has been discussed, but is not possible in the current system. KU Med is leading the way to see if this is something that could be changed in order to allow for this different kind of setup.
- The process for getting system wide AP credit scores has finished successfully.
- The American Council on Education has recommended that students getting sufficiently high scores on sections of the GED should receive college credit. In the case of College Algebra, the GED does not cover common content required for College Algebra. President Bennett sent concerns regarding this and providing college credit to GED students to KBOR.
- The KBOR testified against a bill presented in a legislature committee, which would strip the Board of Regents and colleges and universities of their authority regarding weapons on campuses. President Bennett believes this bill is now dead.
- Brian Lindshield will be chairing the Council of Faculty Senate Presidents in the next academic year.
- The students now have affiliate members on a number of KBOR committees that are not open to the public: fiscal, academic affairs, and government. There has been some discussion among the Council of Faculty Senate Presidents if this is something they want to pursue as well.
