- 1. President Andrew Bennett called the meeting to order at 3:30 pm.
- 2. The October 25, 2016 Executive Committee minutes stood approved as submitted.
- 3. Report from Standing Committees and Student Senate
 - A. Academic Affairs Teresa Hartman/Jenny Bormann
 - Proposed items for Faculty Senate consent agenda (pages 2-5) Attachment 1
 Hartman moved to place the consent agenda on the December Faculty Senate agenda. Motion carried.
 - Proposed items for Faculty Senate discussion agenda (page 6) **Attachments 2 & 3**Hartman moved to place the discussion agenda on the December Faculty Senate agenda.

The discussion agenda includes the Undergraduate Interdisciplinary Certificate in Integrated Risk Management. Jennifer Merrill spoke about this certificate and answered questions. The certificate will be offered through the Center for Risk Management Education and Research through the Colleges of Ag, Business, and Engineering.

The discussion agenda also includes the new undergraduate Biomedical Engineering degree program. Don Gruenbacher and Steve Warren spoke about this program and answered questions. There is student demand for a B.S. program in Biomedical Engineering, and the only other one available in Kansas is at Wichita State University. Senator Lindshield recommended that information be added to the catalog course description for BME 200 to describe how the course will meet the Human Diversity within the U.S. K-State 8 tag.

The discussion agenda was approved to be placed on the December Faculty Senate agenda.

- CIP Code change requests informational item Attachment 4
 A question was raised regarding the process for a program to change the CIP code. Academic Affairs developed and approved a signature sheet to be used for this process (Attachment 4). CIP code changes will be approved by the department head, dean, dean of the Graduate School (if a graduate program), and the provost. This will be an informational item for Faculty Senate.
- Resolution regarding Solar Eclipse on August 21, 2017
 A motion was made to place a resolution regarding the solar eclipse on August 21, 2017 on the December Faculty Senate agenda.

Chris Sorensen from the Physics department was present to address this topic. There will be a solar eclipse on Monday, August 21, 2017, the first day of class, at approximately 1:00 p.m. This is a total

solar eclipse and it will pass through northeast Kansas and Nebraska. This is the first time there will be a total solar eclipse in many people's lifetime and many students will want to see this. There was discussion regarding Monday evening graduate seminars and it was decided that the resolution may include that classes will begin Monday evening. Additional discussion included university operations on that Monday, and it was concluded that we are asking for classes to be postponed, not for the university to be closed.

The motion carried.

• Curriculog

The Curriculog Implementation team has decided on an implementation date of February 1, 2017 for the identified pilot colleges to use Curriculog for course proposals. Curriculum proposals will be implemented at a later date.

- B. Faculty Affairs David Lehman / Charlie Barden
 - University Handbook, Section C
 Barden reported that Provost Mason reviewed the changes that were approved last May in Section C
 and submitted various comments, questions, and suggested edits regarding the changes. Faculty
 Affairs (FA) and Professional Staff Affairs (PSA) reviewed those and responded. Provost Mason is
 now reviewing these latest updates made by FA and PSA in Section C.
- C. Professional Staff Affairs Loleta Sump / Mary Anne Andrews
 Sump concurred that PSA reviewed portions of Section C with the provost's comments and
 suggestions. It was noted that Section C.8. defines professional staff based on what they are not. PSA
 revised the language to be more positive and define professional staff by what they are, not what they
 are not. Section C31.1 discusses evaluations for professional staff. At this point because of Total
 rewards, PSA could not make any solid decisions on this section so they are going to leave it as is until
 Total Rewards has been implemented. They will review it again then.
- D. Student Senate Jack Ayres
 Student Senate is preparing for their last meeting of the semester this week.
- E. Technology Lisa Crawford Craft / Michael Raine No report
- F. University Planning Spencer Wood
 - City/University Project Fund recommendations
 Attachment 5 includes the slate of City/University Project Fund recommendations that came forward from Faculty Senate, Student Senate, and University Support Staff Senate. This report has been forwarded to the president. All of the recommendations revolve around walkability and safety enhancements around campus.

Senator Wood raised concerns regarding the budget and indicated that he has heard a number of concerns from faculty members regarding the current fiscal situation in their departments and how future budget cuts would be detrimental to their departments. He announced FSCOUP will be discussing the budget more in their next meeting.

President Bennett indicated that the university budget committee is not contemplating furloughs or exigency. According to Sue Peterson, we will not know anything until December 5th when the legislature appoints committee chairs. She has indicated that it is not known how the House and

Senate will play out until the leadership is determined. The Governor does not anticipate making any allotments, but we do not have a balanced budget.

4. New Business (4:20-4:39)

- A. Future guests to Faculty Senate (General Counsel, K-State Proud, etc.)
 We typically invite the provost to the Faculty Senate meetings and there has been discussion of inviting other entities. Three people were discussed: (a) President Myers, (b) General Counsel, and (c) K-State Proud. The topics of discussion for each entity are included below.
 - President Myers his vision now that he is the permanent president, budget, access and affordability
 - General Counsel sexual assault lawsuits, diversity language (i.e., hate speech and dispelling students)
 - K-State Proud explain how this organization works to retain students

A motion was made to invite President Myers to the December meeting. Motion carried. A motion was made that if President Myers is not available in December, we will invite K-State Proud. Motion carried. We will look into inviting General Counsel to the February or March meeting.

B. Location of June Faculty Senate meeting

There has been discussion by the FSLC to hold our June Faculty Senate meeting in Salina. The K-State Polytechnic campus has volunteered to pay for half of the fees for a bus and the Provost will pay for the other half. Faculty Senators will be able to tour the campus and see what is involved on that campus. This will enable Faculty Senate to have a better understanding of the Polytechnic campus and the needs of that campus. Because the campus location of the FS meeting is not usually changed, there are not any hard and fast procedures. However, it was determined that this should be voted on by Faculty Senate.

A motion was made and seconded to put this item on the December Faculty Senate agenda for a vote. Motion carried.

- C. Honorary Degree Candidate (May 2017 commencement)
 A motion was made and seconded to place the Honorary Degree Candidate item on the December Faculty Senate agenda. Motion carried.
- D. A motion was made and seconded to approve the following faculty senator replacement: Sarah Reznikoff for Eric Maatta, Arts and Sciences (December 2016-May 2019)

 - A. Report on November 16 Kansas Board of Regents meeting
 President Bennett reported that Wichita State University has now granted in state tuition to metro
 Kansas City. This is in addition to Pittsburg State University. This issue is being debated on our campus.

The weapons policy of all six regent's institutions have been submitted and will go forward for a first reading at the December meeting. President Bennett indicated that he believes our policy will not be able to have the child development centers as restricted areas.
