# Faculty Senate Executive Committee Tuesday, January 29, 2019, 3:30 pm Union Wildcat Chamber

1. President Spencer Wood called the meeting to order at 3:34 pm.

2. The November 27, 2018 Executive Committee minutes were approved as distributed.

- 3. Report from Standing Committees and Student Senate
  - A. Academic Affairs Jenny Bormann/Todd Easton
    - Proposed items for consent agenda (pages 4-7) Includes Attachment 1 and 1a
       All items were approved to be placed on the FS consent agenda for February (This also includes
       some proposals that are conditional; inclusion on the Faculty Senate agenda is based on approval at
       the 2-5-19 AAC meeting).
    - Proposed items for discussion agenda (page 8) Includes Attachment 2
       All items were approved to be placed on the FS discussion agenda for February, except FNDH 321.
       (This also includes some proposals that are conditional; inclusion on the Faculty Senate agenda is based on approval at the 2-5-19 AAC meeting).
    - Proposed addition to UH, Section F104 Attachment 3
       The Academic Fresh Start policy has been in existence since 2008. However, it was not placed in the University Handbook and this rectifies that issue (there are no changes—this change only incorporates the policy into the Handbook). It was unanimously approved to add this item to the Faculty Senate Agenda.
    - Consent agenda items proposed change procedures:
       Easton outlined a possible change in procedures that would provide for allowing the Faculty Senate Executive Committee to approve moving course and curriculum items to an agenda for the regular meetings of the full senate as place holders pending action at the Academic Affairs Committee meeting that occurs in between the Exec and full Senate meetings. The purpose in proposing this change would be to speed up the approval process for those items. Based on the feedback received, Exec committee members were supportive of this if Academic Affairs chooses to move forward with this. This will be done in concert with a re-examination of the approval, routing, and notification procedures.
    - Departmentally approved course lists Academic Affairs Committee has noticed that many departments create lists of courses that are approved for fulfilling electives within a curriculum. The accuracy of these lists has been raised as an area of concern as well as the accuracy of categories ascribed to which electives are fulfilled by particular classes (i.e., whether a class one department determines is a humanities course is really a humanities course, or earth sciences, or fine arts, etc.). Academic Affairs will have their committee members do some research into existing lists and, if needed, may develop best practices for these.
    - Continuing to work toward an updated K-State 8 tag review process and perhaps updated criteria. The co-chairs will be meeting with provost staff in the near future to discuss.
    - A new Approval, Routing, and Notification Procedures document continues to be worked on to update and to increase efficiency.

Academic Affairs is considering developing a template and procedures for BS-MS programs that can
be adapted to any majors that will allow students to earn a concurrent degree where nine hours of
graduate credit would be counted as credit toward the undergraduate degree.

### B. Faculty Affairs – Charlie Barden/Amy Betz

- Proposed revisions to University Handbook, Section K, General Services Attachment 4
   This was an overall review of the language in section K. A comment was raised about how
   "Manhattan-centric" the section is and that it does not apply equally to all campuses. This makes it
   very confusing for non-Manhattan campuses. It was requested this section be returned to the
   Faculty Affairs Committee for further refinement.
- They are still gathering information on representation of term faculty employees. There will be a joint meeting with the Professional Staff Affairs committee in February to discuss this further.

### C. Professional Staff Affairs – Kelly Briggs/Ashely Thomas

• They will be meeting with the Faculty Affairs Committee to discuss representation for term unclassified professional employees.

### D. Student Senate – Ryan Kelly

- This is Wildcat Welcome Week. They've had a lot of activities going on and attendance and participation by Faculty Senators was encouraged.
- February 8<sup>th</sup> is the deadline for students to submit applications for SGA positions.
- The Tuition and Fees Strategies Committee will be having its first meeting of the semester on February 5<sup>th</sup>. Dean Dawson will be presenting on the College of Engineering fees. A question was raised seeking clarification on the deadline for Engineering students to apply to serve on the college tuition committee (CTC) and the tight timeline. Kelly explained that it was necessary to allow the committee to be created in time for the February 5<sup>th</sup> meeting. Fifteen applications were received, 2 applicants withdrew, and the remaining 13 were all appointed to the committee.

### E. Technology – Brian McCornack/Michael Raine

- Phishing scams: Senators were urged to please be aware of phishing scams and to communicate
  with faculty, staff and students in their areas about the need to be vigilant in protecting personal
  information and not falling prey to scammers. Examples of impacts on individual employees were
  shared to illustrate the importance of using caution in discerning validity of emails.
- Rob Caffey, Special Assistant to the CIO Duo-Two Factor Authentication: this will protect personal data and reduce data breaches. It also brings the university into compliance with IT security standards. There are several options for users to set up authentication methods. ITS is starting the implementation with professional staff, then will move to faculty and then students. There will be a traveling help desk that will work with the target groups being enrolled (specific colleges or departments on their migration days). The students at the IT Help Desk are also able to assist users in getting in enrolled. Faculty and staff going abroad are encouraged to utilize the key fob to have secure access (\$25 each) while traveling, but other Duo access options are free to users.
- F. University Planning Valerie Barnett/Laurel Littrell No report; the committee did not meet in January.

### 4. Announcements

A. President Wood announced that President-elect González is the recipient of the Commerce Bank faculty award for excellence in diversity (which she was receiving at the time of the Exec meeting).

- B. KBOR meeting report:
  - KBOR approved a pilot project regarding the proposed change in policy allowing 45 hours from a
    university degree combined with the remaining hours transferred from a community college. It will
    sunset in four years.
  - Program review policy change that we were wary about is being applied to KU and Wichita State
    University right now. It appears those universities were the intended targets for the new policy.
    They will report in June on programs that are not performing well, but a result from this process
    may not be known for one year.
  - International Baccalaureate (IB) courses are not seen as equivalent with AP courses in Kansas, but they are recognized in neighboring states. This may be a source of losses in enrollment. KBOR is now developing a policy that will allow Kansas universities to permit IB credits similar to process for AP credits.
  - Open access resources policy is being developed and has been brought forward by the student body presidents. K-State's name pops up all over the document proposing investment in open access resources and it's clear the KBOR knows we have been out front in incorporating these into our courses.

- E. President Wood announced that the President's Award of Excellence Selection Committee has put out the call for nominations for the award for unclassified staff, which went out on January 14<sup>th</sup>. The deadline for nominations is February 15<sup>th</sup>. Senators were encouraged to spread the word and make sure excellent people get nominated and recognized.
- 5. Open discussion period for senators as needed:
  - A proposed academic calendar was brought to exec in November and sent back to the calendar committee for discussion regarding spring break dates. Our spring break currently moves to accommodate the Board of Regents meeting, which at times, can create a lot of jockeying around with course syllabi, planning, etc. There is consideration of recommending spring break occur during a fixed time period each year (2<sup>nd</sup> week in March, for example).
  - Libraries Subscriptions: Pitts announed that there wil be an open forum to address concerns, answer questions, hear about subscriptions needs, etc. It will be February 12<sup>th</sup>, 11:30-12:30, in Town Hall of the Leadership Studies Building.
