#### E. Student Senate – Blake Phillips / Michael Dowd

Dowd had no item to report. However, clarification was asked for about fall 2021 sorority recruitment updates. Round 1 will be totally virtual. In-person recruitment starts Thursday night, the first week of classes, and continues through Sunday each evening after classes, per Mary Oborny, a sorority advisor.

#### F. Technology – Brett DePaola/Michael Raine

A joint meeting was held with Faculty Affairs to discuss a possible resolution surrounding TopHat. After much discussion, no resolution came forward. However, one may be produced by FSCOT in the fall. The recommendation would be to use TopHat only for a few free features and continue to use Canvas. There will be more discussion in the fall, but this is something perhaps the academic technology tools committee, when charged, will work on in future.

#### H. University Support Staff Senate – Mary Oborny

During our last meeting we had a Vice President and President Elect nominated for next year, Monica Macfarlane, from Ag. We have a full board. The senate also approved revised by-laws and will now go to an all at-large representation, with the exception on of senator from Salina.

#### 5. New Business

A. Honorary Degree Candidate (December 2021)

President Littrell reminded senators this information is confidential until approved by the Board of Regents. Committee members were provided the candidate's information packet via email. A motion was made by Senator Von Bergen and seconded by Senator Dodd to place this on the upcoming Faculty Senate agenda for approval.

Motion carried.

B. Faculty Senate committee appointments and Presidential committee recommendations
President Littrell referred members to the documents they were provided last week. These documents
show the recommendations that have been made. A motion was made by Senator Saucier and
seconded by Senator Von Bergen to approve the recommendations as provided. Motion carried.

#### C. Ombudsperson appointment (2021-2024)

President Littrell shared her recommendation with committee members. The importance of having a professional staff person among the three ombudspersons has been conveyed and was part of her deliberation. President Littrell recommends that University Handbook language be modified this coming year to codify that one of the three positions will be for a professional staff member and to consider making one of the other appointments optional for a nontenure track faculty position. After further discussion a motion was made by Senator Hosni and seconded by Senator Von Bergen to approve the recommendation for Ombudsperson, Tara Coleman, for the 2021-2024 term. Motion carried.

#### 6. Announcements

A. Faculty Senate President-Elect position.

Senator Don Saucier has accepted the nomination for this position. The election will be held at the June 8<sup>th</sup> meeting.

- B. Senator replacements: AJ Tarpoff for Erin Yelland, Extension (June 2021-May 2023)
- C. KBOR meeting report from May 19-20

A first reading of the new tuition and fee proposal from K-State was presented. There will be an offset by reduction of merging some of the fees, to include online and academic infrastructure fees into tuition. There may be scenarios where students will see a slight increase or decrease to level the money paid to the university. A second part involves a program to update tuition and fees next year. The complexity of college fees will be looked at to make calculations easier for students and families. Deferred maintenance of all university buildings was looked at by an independent consultant. We are looking at \$1.2 billion in deferred maintenance, and the Board of Regents wants to allocate \$10.3 million from the governor to begin to build of a deferred maintenance fund. The Governor vetoed it and the legislature did not override it; therefore, the board of regents is considering how to move forward. This is not a new situation, it has been ongoing for decades, and Kansas is not unique. Increases in tuition typically helps fund deferred maintenance but it affects enrollment and is not always the ideal solution.

- F. Professor and Professional Staff of the Week selections for 21-22 (13 faculty / 8 professional staff)
  President Littrell reminded senators that the professor of the week selections should be submitted to
  Ms. Candace LaBerge by the end of August. A new feature that started last year was the inclusion of
  professional staff members of the week. More information will be sent to caucus chairs via email in
  June.
- G. Meeting arrangements for Faculty Senate meetings (21-22)

  There was discussion if future meetings should be virtual or in-person. Virtual offers a lot of convenience for many different situations and is more inclusive for our non-Manhattan senators and guests. Yet, it's also important to offer face-to-face one or two times a semester or at least during the year, as this offers good chemistry to be together. Several pros and cons were mentioned. Student Senate mentioned utilizing a hybrid situation for their meetings as they have added a global position. President Littrell thanked all for their feedback.

Open discussion period for senators as needed Senators discussed transparency of university decisions (to be asked of the provost in the June meeting), future plans for meeting formats for Faculty Senate, and the importance of continuing shared governance through future leadership changes at K-State.
- 8. The meeting was adjourned at 4:20 p.m.
