## New Business

- ➤ TEVALs
  - Jackie Spears shared that there were concerns raised in the College of Education caucus meeting regarding TEVALs, particularly vicious comments on the open ended questions on TEVALs and students threatening faculty members with poor TEVAL ratings.
  - Issues were also raised regarding the norming of TEVALs, and it was discussed that TEVALs should be renormed today.
  - Jackie asked for examples of TEVAL comments or at the College of Education meeting and no examples were submitted.
  - Other issues were raised, including: a) dissatisfaction with TEVALs in studio courses, b) adjusted scores, c)
    that TEVALs are customer satisfaction survey, d) they're being over relied upon in evaluations, and e) poor
    response rate with online TEVALs.
  - Training was suggested on TEVALs, IDEA, evaluation, etc. for both faculty, department heads, and students.
  - A suggestion was given that the timing of TEVALs should be standardized with training for the students.
  - Jessica Van Ranken said there's been discussion regarding adding a committee relating to Academic Affairs
    in SGA and that this is an issue that could be raised in that committee.
  - Brian Niehoff will talk with Jana Fallin to ask her to convene a focus group to examine issues relating to TEVALs.
