- o Appendix R: Intellectual Property Policy and Institutional Procedure an email was sent to Cliff, and he said he will update us as soon as he has something
- The handbook committee work in the Transmittal Forms Cliff sent the files for feedback and comments we reviewed the documents and sent back to him. We introduced the Proposed change to University Handbook, Sections A3, B35, D30, F1, F2, F6, F20, F122, J1, K73 that is in the Attachment 2. However, there were 2 issues:

- Discussing the ineligibility and rehiring proposed by the HCS Marcellus shared this document to get comments. The HCS wants our feedback.
  - Any additional feedback? Have received a couple of comments.
- Discussion to the need to fund promotions for Instructors/Teaching Professors.
   <u>Instructors/Teaching Professors/other researchers' definitions</u> Discuss similar benefits regarding promotion. Framework for promotion along with financial support for professors. Need to have a clear process and benchmarks providing they have the correct credentials. Financial support may be challenging. Need to share with Academic Affairs and consider joint meeting. The discussion of how to proceed regarding this issue. Perhaps create a subcommittee to present "alternatives"?
- Salary/COLA/Merit we were asked to start a discussion about the Salary/Cola/Merit. The
  former FS president suggested to the Faculty Affairs (and other committees) to advocate for
  offering pay increases based on average salaries rather than using a percentage. I sent an
  email to stimulate the discussion.
- Joint Session with Academic Affairs Dr. Brandon Kliewer, Co-Chair of the Academic Affairs committee, has requested a joint session with Faculty Affairs to discuss Section F revisions as well as the new Planned Leave Policy coming out of CAPP.
