- o Report and recommendations on promoted non-tenure track faculty compensation -
 - Voted on Dec 19th "that the FAC endorse in principle the report and recommendations from the Salaries and Fringe Benefits Committee, and forward to Faculty Senate leadership *both* the report and recommendations *and* the specific caucus-related comments received as of today (including those from Engineering).".
 - However, the FSLC asked we reconsider our edit on omitting the recommend "that all non-tenure-track promotions should receive a salary increase of at least 7.5% of the salary of all faculty at K-State". The logic is that if we do not provide a number, HR will fall back to zero, perhaps there is no funds for salary increase. (Attachment 1)
- <u>Revisions to University Handbook, D-40, D-41, and Appendix S</u> On FS agenda as first read due to extensive changes
 - However, there were a lot of questions at the FS during the first read. Senator Keen reached out to the FAC to discuss it further at our meeting. Amir will take the lead for this discussion. (Attachment 4)
- <u>Handbook Approval Process</u>
 - It was tabled by FS. Now the Handbook committee has completed the necessary updates. We will discuss about the updated documents. Cliff will take the lead for this discussion. (Attachment 2)
