    - ♦ D40-41 no changes
    - ◆ Appendix S Tanya provided a final tweak just before Exec. Exec did not support moving that new version forward to senate without first being reviewed by FAC. However, they did allow that if FAC approves of the newest version during March 5<sup>th</sup> meeting, then the newest version can go forward for vote at senate.
