- 1. President Laurel Littrell called the meeting to order and played a Land Acknowledgement.
- 2. President Littrell inquired if any changes or edits were need to the November 9, 2021 draft minutes. Seeing none, the minutes were approved as submitted.
- 3. Guests: Vice President for Research, David Rosowsky Topic for Discussion: F&A Distribution

The topics covered in his Power Point presentation were Research, Economic Development, and Sponsored Research Overhead. The three pillars of his focus are Teaching, Research and Outreach. Economic prosperity is a priority for the university, not a reach for us, but an affirmation. <a href="https://www.k-state.edu/research//economic-prosperity/">https://www.k-state.edu/research//economic-prosperity/</a>. Our return of Sponsored Research Overhead (SRO) policy dates back to 1965, but we are more progressive and made it simplified, consistent, and equitable. There is a 50% SRO returned to Central Administration, 41.5% returned to the college, 5% returned to OVPR, and 3.5% return to the Library. This applies to all colleges on the Manhattan Campus and to all grants awarded starting in FY23. The office will continue to support matching requests at the same level, 25% start-up and 33% matching funds, and no change to major equipment. He is working hard to identify new resources external to the university with a priority on increasing not the percentage but the number of matching requests that can be supported. SRO policy remains outside the RCM, so it will stay with the Vice President for Research. He mentioned to watch for research highlighted in SEEK Magazine. "Growth in research is not at the expense of great teaching, indeed it's to its great benefit." (D. Rosowsky). He entertained questions about SRO distributions, regarding facilities, labs and class space, on and off campus. He shared areas where we can continue to become global leaders in regard to food securities and global challenges.

Approval of Consent Agenda (pages 5-7) – Don Saucier
 President Elect Saucier inquired if any items should be moved to the discussion agenda. Seeing none, the consent agenda was approved as submitted.

- 5. Report from Standing Committees, Graduate Student Council, and Senates
  - A. Academic Affairs Jenny Bormann/Don Von Bergen
    - Discussion agenda items (page 8)
       Senator Bormann made a motion to approve the various new curriculum items as listed on the discussion agenda. Motion passed.

The Undergraduate Academic Credit Certificate policy had some additional questions that needed resolved and therefore, it will likely come back in February. Academic Affairs continues their work on the interdisciplinary program approval process. This may be slightly delayed as they are considering a possible different approach to this. They also continue to review the post-bacc minor policy and the posthumous degree policy. Other work continues that has been previously reported on.

- B. Faculty Affairs Marcellus Caldas/Veronica Denison Senator Denison shared they have been requested by the University Handbook and Policy committee to begin work to revise Appendix R related to Intellectual Property Policy and Institutional Procedures. As a potential addition to the handbook, they continue to look at a definition of Community Engagement. Additionally, as they committed to Faculty Senate back in May, they have been working on and recently finalized shortened syllabi statements and QR links for these that faculty may utilize. - C. Graduate Student Council Pingping Chen or David Marcus
  Grad students had an end of the semester party on Dec. 8. Please encourage graduate students to
  apply for executive positions this spring. There will be a tech read research forum in the spring and the
  deadline will be in March. They will also launch a safe space for graduate students in February 2022.
  They continue to work on the details around the Advisory Council form.
- D. Professional Staff Affairs Renee Gates/Mishelle Hay McCammant
  They continue to collaborate with FSCOUP on CCOP language and recommendations for composition
  of those bodies. They are also crafting suggested wording for an ombudsperson rewrite for the
  University Handbook. A sub group continues to work on staff recognition and staff spotlights. Finally,
  they would like to come back to assisting HCS with suggestions for improvement of career ladders.
- E. Student Senate Blake Phillips

They wished good success to students on their finals. There are seven SGA meetings left until their term is over. A representative for SGA from Faculty Senate has been appointed and from the Vice President for Student Life Office as well. SGA just approved a new subcommittee on strategic oversight to help with transitions of newly elected SGA leaders and help with report structure and continuity. They continue to review and evaluate the Student Services fee contracts.

F. Technology – Brett DePaola/Michael Raine

They were briefed about the infrastructure refresh. It is going forward and is funded. Due to supply chain issues the outdoor is being upgraded more rapidly than the indoor. This does not come down to a question of prioritizing, but supply chain. Regarding Cyber Security training, it has noted that many personnel have not completed their training as originally requested to be done by Dec. 31, 2021. (Gary Pratt noted that the Cyber Security Training deadline has been extended to February 1, 2022). There will be phishing attack simulations pushed out as a security test. Classroom technology refresh is delayed due to supply chain. It was clarified that the LOG4J issue is not a phishing attack, rather this is something that texts a system directly. However, our IT Teams have done a great job looking at our

systems to keep them protected. We have scanned about 65,000 IP addresses checking against vulnerability and we fared well. The Kronos time and leave system was hacked but payroll procedures carried on without interruptions. No sensitive information was leaked related to this; it was more of an inconvenience. ### G. University Planning – Martin Seay

They had a meeting with Karen Goos and Tammy Byland that provided good insight around strategic enrollment management; they were open to guidance and feedback. Had a good visit Tanya González and Dean Debbie Mercer about APRR process, while trying not to duplicate services. Their committee received feedback from Faculty Affairs and Professional Staff Affairs committees about CCOP composition. Feedback from the University Handbook committee has also been received.

H. University Support Staff Senate – Mary Oborny or Monica Macfarlane No report.

#### 6. New Business

Honorary Degree Candidate.

President Littrell indicated that the confidential information regarding the honorary degree candidate was sent to senators prior to the meeting. She entertained a motion for approval. Senator Haub moved to approve the candidate. Senator Korten seconded. Discussion: It's an excellent choice. The motion passed.

#### 7. Announcements

A. KBOR will meet Dec. 15-16<sup>th</sup> and there is a lot of activity including the selection of university presidents for Emporia state and Pittsburg State. The board is hearing a second reading of Housing and Dining requesting rate increases, K-State has not requested an increase. They continue to look at student health centers, in regard to third party insurance collection of fees and efficiencies for student health care. Building maintenance and new building construction will also be discussed. The meeting agendas are always posted on the Board of Regents website and the meeting is live streamed. The Council of Faculty Senate Presidents was hoping to have an agenda item regarding stopping the tenure clock for faculty appointed in 2020-2021, they are hopeful that it will be on the agenda next month. Pretenured faculty members had a year added to their tenure schedule. This would affect faculty appointed since this policy went through (due to COVID impact). There was discussion on TEVALS policies being extended and used for tenure and promotion also due to COVID. TEVALS should be used as a measure for student satisfaction not for a measure for tenure.

### B. Term Appointment Caucus elections update

President Littrell was pleased to announce that the inaugural election for the Term Appointment Caucus has concluded. Winners and runners-up have been notified today and President Littrell is organizing a meeting with these newly elected senators to help them get them oriented to Faculty Senate. As a reminder, the composition of the Term Appointment caucus may include members from all colleges, extension, the libraries, and the General University unit. However, there will not be more than two term employees from any college, extension, the libraries, or the General University unit. President Littrell shared the names of those elected to serve on this caucus: Mary Bowen and Deborah Kohl, Agriculture; Graciela Berumen, Education; Erin Bishop and Tandy Rundus, Extension; Clara Kientz, General University; and Jennifer Miller and Suzanne Reese, Health and Human Sciences. Please take a moment to send these new senators your congratulations. They will join us for the next faculty senate meeting.

- 8. Open discussion period for senators | New Initiatives | For the Good of the University It was suggested to invite Karen Goos, Vice President for Enrollment Management, for a spring meeting to discuss strategic enrollment management and student recruitment as there have been some concerns related to this. President Littrell will follow up on this. Kimathi Choma will be our guest in spring as well to share more about his role as Student Ombudsperson. There was discussion about the Presidential Search process being more open and engaging.
