#### Attachment # 2:

Jason Maseberg-Tomlinson, General University, Director, Student Access Center:

We are starting to struggle with course document remediation and how we can better support faculty. As more readings move online we need to work with more documents for students who have alternative text accommodations (a need for accessible documents). We continue to run into PDFs without OCR or accessibility. Ideally I would like to see a tool such as Blackboard Ally but I know the time and expense to set that up is a concern. We are looking at other tools that may be less resource demanding. Currently we have staff go into courses (we ask instructional designers if the college has them) and we comb for files with faculty. Then we manually work them or send them to a service for remediation. As you can imagine, it is getting more and more complex. Our office does not have the staff to keep up and faculty do not have the resources available (training, technology, etc.)
