1. Call to Order
a. Meeting was called to order @ 3:00
2. Past minutes
a. Minutes from April, May, and September voted on. All approved.
3. Tuition and Fees Committee Update with Karen Goos
a. Provided updates and clarifications on the Change in K-State's Tuition and Fee Structure.
b. Need for revisiting exacerbated by COVID and the shift to online.
c. November 2020 Task Force on University Tuition and Fee Structure established by the President and Provost.
i. Co-chaired by Kevin Gwinner Dean of College of Business Administration and Thomas Lane VP for student life.
d. Examined fees at peer institutions. Examining admitted vs enrolled data and looked at understanding the market base in KS and with competitors.
e. Explained process, composition of stakeholders which included students, and the outcomes/opinions so far.
f. Questions?
i. Timeline to implement and get enacted was short. Still ongoing in phases.
4. Assessment and initial moves in June. Surprised at low number of students impacted incorrectly.
5. Disappointed with active vs. term dates with change of major in Peoplesoft and need to future date.
6. Considered a win that students and families can understand the fees and structure easier.
ii. Plans to look at differential tuition.
iii. Hold until later phases. Will take longer because it creates complexity and requires more conversation.

d. Michael Dowd- Student Services Fee at two million deficit going through insufficient funds process, one million in recall one million in bond surplus.
i. Low enrollment.
ii. Long term lack in cuts. Fiscal responsibility in managing those funds needed.
iii. Need to increase fee or look at expense cuts long term. - KBOR resistant to increasing fees student initiated or otherwise.

B95 Language Sent from Daniel Ireton

## B95

Members of CCOP shall be limited to and elected by faculty and unclassified professional staff, with the exception of department heads or equivalent and deans, who are assigned to a college, department, or other unit. The faculty and unclassified professional staff of each college or unit shall be responsible for establishing its own election procedures; this procedure must be approved by a majority of the college or unit. Membership shall represent a cross-section of departments, discipline areas, or other organizing units within the college or administrative unit. In addition, the college or administrative unit's FSCOUP representative will be an ex officio member of CCOP. A copy of CCOP election procedures shall be kept on file in the office of the secretary of the faculty senate.
