Proposal:

Align the Summer Semester Grade Submission Deadline to the Tuesday after the end of the primary summer semester (currently 12-weeks).

Background:

The University Academic Calendar Committee was tasked to discuss the summer semester grade submission deadline stemming from some timing issues with the Summer 2021 PERC reports along with additional items discussed at the Wednesday, September 8th CAPP meeting. Based on the discussion administration felt it would be a good topic for collaboration and discussion between CAPP and the University Calendar Committee, resulting in the creation of a joint working group.

The working group was charged with a discussion and recommendations/changes to processes/procedures connected to the summer grade submission deadline.

Current business practice is the summer grade deadline waits until the Friday at the end of the Summer Intersession instead of running with the normal Fall/Spring cycle of the Tuesday after the end of the primary term.

In other words, summer 2021 had a grade submission deadline of Friday, August 20th instead of the Tuesday after the end of the primary semester (12-weeks) which was Friday, August 13th.



If we followed the normal Tuesday submission date that would have made the grade deadline for summer courses Tuesday, August 17th. For context, there were only 22 sections with 210 enrolled students, that ended after 8/13/21 and 11 sections with 115 enrolled students, affiliated with the August Intersession part of term (8/2/2021 through 8/20/2021).

It is important to note that All NST courses have an automatic grade reporting cycle that is triggered based on the term and end date of the course which triggers an e-mail to the instructor of recording reminding them to report grades within 5 business days of the end of the course. Resulting in any course ending after 8/13/21 being captured and graded.

Issue:

The Office of the Registrar has received more questions and complaints from students, faculty and staff around the delay in grading for summer. We are experiencing some issues with the delay in the grade deadline such as a delay in the conferral/posting of degrees (we cannot post until after the grade deadline), the PERC process which meant for this summer students that did not meet the prerequisite requirements from a summer course for fall enrollment (these students were not dropped from the course until mid-week of the first week of fall classes), etc.

If the deadline had been on Tuesday, August 17th that process could have run prior to fall start allowing for students to have more time to choose/replace courses that were dropped due to this process.



Research/Discussion:

Peer Research really highlights that there are noticeably clear buckets in summer (like a 4-week/4-week/4-week; 8-week and 12-week offering)

At most institutions, this is known as a Part of Term – having more defined parts of a term in fall/spring and summer might be a point of conversation or future consideration, instead of everything being affiliated with one code of NST (Non-Standard Term) in KSIS.

Buckets appear to be in a more student-centric approach – what helps students accomplish the achievement of completing courses in smaller bites and helps students work around and accommodate their work and personal schedules.

Shift in deadline will allow areas such as the Graduation/Degree Analysts functions in each college to be able to review and clear students earlier. These functions cannot begin final reviews and clearances until after the grade submission deadline.

Education Abroad: there are nuances to how the Faculty Lead programs work, and international institutions have different start/end dates outside of the boundaries however, those exist in every semester and are worked through in consultation with the Education Abroad Office, College/Academic Department and Enrollment Management units.
