- 4. Old Business
  - a. Update on Listening Sessions
    - i. Sessions are scheduled for the week of Feb. 10.
    - ii. They requested names of people to email, there would be 12-15 people in each session, and there would be 6 sessions on campus. Olathe will be invited to zoom and on-campus session and one session will be at the Polytechnic campus.
    - iii. Sessions will be held in Throckmorton, Union, Business Building, and Dole
    - iv. Need at least 2 people from our committee to help take notes in each session. This means everyone on the committee should sign up for at least 1 session. It will also be recorded.
    - v. Still issues with the listserv picking up the correct people. Trying to work this out.
  - b. Update on Climate Survey
    - i. Will be sent out February  $5^{th}$
    - ii. Most questions are canned, there really isn't much opportunity to change the questions
    - iii. They did send a survey out to a pilot group
  - c. Dependent Tuition Benefits
    - i. Not likely to be pursued at the University level, however, at the December KBOR meeting, KBOR showed interest in this being implemented statewide.
      - 1. One potential benefit is they may consider giving university employees the same opportunity as KBOR employees where they can take courses at any Regents' Institution

- 2. KBOR has suggested if it is done at their level, it would be a waiver if that is determined, it would be easier to expand it
- 3. Will have to look eligibility parameters

- i. KU shared some survey information from their own survey
  - 1. It showed the relationship with the supervisor impacts how long employees stay in their position
- ii. Good training, encourage supervisors to take it

- i. Docking Institute Survey was presented to counsel presidents and KBOR, encouraged to do the survey every 3 years. Everyone was very receptive to the survey.
- ii. February 3<sup>rd</sup> tentatively set to go to Topeka
- iii. Sue Peterson and President Myers have agreed that USS leadership no longer need to take vacation or take their own personal vehicles to Topeka
- iv. President Myers gave green light to get the employee suggestion program back up and going. They have met with Jay Stephens about it. Conversations on where it would be housed. Potential to house it through FSCOUP
  - 1. Potential for awards if the suggestion is adopted and there is a large cost savings (perhaps even an award of 10%)
