Enclosed are nomination materials in support of Dr. Jason Grady's application for Clinical Graduate Faculty membership in the Department of Clinical Sciences. Dr. Grady is a Clinical Assistant Professor who is currently an Associate Graduate Faculty member. The enclosed Graduate Faculty application materials are being submitted for consideration because Dr. Grady is a clinical faculty member in the Department of Clinical Sciences and at the time of his initial nomination as a Graduate Faculty member the designation of Clinical Graduate Faculty had not been introduced. With this updated Graduate Faculty designation now in place, this is the more appropriate Graduate Faculty designation for Dr. Grady.

Dr. Grady received his Doctor of Veterinary Medicine (DVM) degree from Kansas State University in 2003. He then completed his residency and a Master's degree from Kansas State University in 2008. Dr. Grady successfully earned Board Certified from the American College of Veterinary Internal Medicine-Large Animal (ACVIM-LAIM) in 2009. Dr. Grady served as an associate veterinarian in private practice in Oklahoma from 2008 – 2015. His clinical expertise while in private practice was equine reproduction.

In 2015, Dr. Grady joined Kansas State as a Clinical Assistant Professor with an emphasis in equine theriogenology (reproduction) and ambulatory field service. His allocation of effort is 70% clinical service and teaching, 15% didactic teaching, 10% research / scholarship, and 5% non-directed service. Dr. Grady provides both routine and complex reproductive management services for the breeding of mares and management of stallions. Dr. Grady provides routine and advanced care for local / regional equine clients through equine ambulatory services. Dr. Grady also assists with in-house equine internal medicine cases when needed.

Dr. Grady delivers an important component of core lecture material (15 hours) to third year DVM students by teaching a portion of VCS862 Theriogenology (3 credits). With regard to contributions to senior year clinical training, Dr. Grady is the course coordinator and primary clinician for delivery of VCS921 Clinical Equine Theriogenology, which is an elective clinical rotation that is offered during the equine breeding season from March through July, annually. In addition, Dr. Grady contributes to VCS923 Advanced Equine Studies elective and VCS924 Equine Field Service clinical rotations. With his unique interest in equine reproductive services, Dr. Grady intends to mentor graduate students working on a post-graduate degree in the field of large animal reproduction.

From October 9 – October 23, 2020, Dr. Grady's curriculum vitae and a ballot were circulated to 40 Clinical Sciences faculty eligible to vote on his nomination for Clinical Graduate Faculty status. The results were 37/40 members voting in support of his nomination. Three members were unavailable to vote. 

Please accept this letter of nomination in support of Assistant Professor Paul Karr’s application for Associate Graduate Faculty membership. In this capacity, he would be eligible to teach graduate level courses and serve on graduate committees. Paul joined our faculty in 2017 as a full-time instructor while pursuing his M.S. in Architecture from Kansas State University, which he completed in spring 2020. He was promoted to assistant professor this fall and is now tenure-track. According to university policy and our Departmental Documents, his M.S. degree meets the requirements for a terminal degree. Paul earned his B.S. in Construction Science at K-State in 1988. He brings a unique skill set in that he is a graduate of our construction science program, but spent the majority of his career as a design engineer of mechanical, electrical and plumbing systems. His nearly 29 years of industry experience, combined with his cross-discipline experience, adds valuable depth in this area of coherence among our faculty. His unorthodox career path will resonate well with both our architectural engineering and construction science students.

Paul is a licensed Professional Engineer in the State of Texas. His extensive background and interest in mechanical, electrical and plumbing systems design adds depth and breadth to our faculty and his AutoCAD and building information modeling expertise greatly enhance our curriculum.

Prof. Karr is currently assigned to teach CNS738 – Mechanical & Electrical Estimating. Granting him Associate Graduate Faculty status will allow us to offer this course for graduate credit without a co-instructor. Other courses which he would be eligible to teach include:

We currently have only one to two Graduate Faculty and one Associate Graduate Faculty with the qualifications and expertise to teach the seven courses referenced above, and these are in addition to the average of 3-8 undergraduate credit hours that each is already assigned each semester. As a department, we do not have the bandwidth to offer the full complement of mechanical/electrical/plumbing design-focused graduate courses with just these faculty, which severely limits the opportunities for our M.S. and M.S./B.S. students. Our department has historically placed greater emphasis on extensive professional engineering design proficiency than on research and publications when filling open tenure-track faculty positions. Prof. Karr has the technical expertise to teach each of these courses as the result of his experience in the design profession and he will apply for full Graduate Faculty status upon being published in a refereed journal.

Prof. Karr has earned the respect of his peers and students alike. He consistently has among the highest teaching evaluations in the department, he has earned numerous teaching/advising awards, he played a major role in resurrecting our CNS738 M&E Estimating course, which essentially had to be recreated from scratch, and he has an excellent service record that includes advisor to the Mechanical Contractors Association of America (MCAA) Student Chapter, coach of the MCAA competition team, coach of the U.S. Department of Energy Solar Decathlon Team, and multiple chair/committee assignments at the department level. Paul places the needs of his students first, and he is a dedicated faculty member. He has earned my esteem and I give him my highest recommendation. Thank you for your consideration.

*Utilization of low falling number wheat (2018-2019).* FN is a critical quality parameter for the wheat flour milling and baking industry. FN of wheat will drop to below commercially acceptable levels (~250-275s) if it is hit by excessive rains in the late season, which could be catastrophic for wheat farmers (loss from 25¢ to \$2.0 per bushel). I innovatively applied a special treatment process on flours from low FN wheat (FN from 70s to 175s) and turned all the low FN wheat flours into quality cake flours.

*Development of non-chlorinated cake flours and establishment of reliable QA method (2014-2015).* Right after I joined the Mennel Milling Co., the Company decided to develop non-chlorinated cake flour to meet the demands of health-conscious customers. I was assigned to take up this task and developed two high-quality non-chlorinated cake flours from both hard and soft wheat flours using heat treatment, which are still recognized as the best heat-treated cake flour in the industry. I also established a quick and reliable QA method, which has not failed a single batch in more than five years.

*Established validation protocol for thermal processor and conducted in-plant process validation (2013-2019).* As customers' requirements on microbiological standards of heat-treated flour get tighter over the years, 5-log reduction on potential food pathogens becomes industrial norm. I established the in-plant validation protocol for all the thermal processors in the company and validated >5 log reduction for all the heat treatment and RTE flour processes.

It is my pleasure to nominate Dr. Abbie Viscardi for membership **with certification** of the Graduate Faculty of Kansas State University. Dr. Viscardi joined the Department of Anatomy and Physiology as a Research Assistant Professor in July 2018 and was admitted to graduate faculty membership at that time.

Dr. Viscardi received her PhD in Animal Behavior and Welfare from the University of Guelph in April 2018. Her project entailed the assessment of 3 analgesics and 1 topical anesthetic (administered alone, and in combination) for their ability to alleviate pain in piglets undergoing surgical castration and tail docking. Dr. Viscardi also developed and refined a groundbreaking Piglet Grimace Scale (PGS) for pain assessment and organized a training module to teach others how to properly use the scale. Dr. Viscardi has published 7 peer-reviewed manuscripts in high impact journals. She has also recently received notification that she was awarded a \$500,000 grant from the USDA to investigate the transmammary delivery of pain relief drugs from the sow to the piglet at the time of processing. This award will fund the training of graduate students in her laboratory underpinning the need for her to be certified to train doctoral students.
