 Graduate Handbook Change. <u>Chapter 2, The Master's Degree, Section D8,</u> <u>Off Campus Research</u> - Reading Two <u>Rationale for change:</u> Remove the paragraph because it is redundant to Chapter 2, Section J2 "Scheduling" where the information seems to be more relevantly placed. Similar language is used in Chapter 3, The Doctoral Degree.

# b) Off Campus Research

Special difficulties arise in guiding graduate students when they are engaged in protracted off campus research, whether that research is in the field, in the laboratory, or in the library. Therefore, supervisory committees must take adequate steps to ensure appropriate guidance. As a minimal requirement, the student must submit to the supervisory committee a well formulated research plan, including objectives and methodology, and the committee must review and approve the plan before the student departs for the research site and indicate approval on the program of study. In addition, the supervisory committee may require:

a. That the major professor and/or a competent local authority who can reliably guide the student provide continuing on-site supervision.

b. That the student provides the supervisory committee with frequent, periodic estimates of performance and progress. The committee may also require that these be authenticated by a competent local authority.

c. That the major professor carries out local inspections of the student's activities.

Regardless of the location at which the research is conducted, the final oral examination will normally be given on the Manhattan campus unless the academic program is completely online. Exceptions can be made if requested by the student, recommended by the supervisory committee, and approved by the Department Head or Graduate Program Director and the Dean of the Graduate School. In the case of an examination in which the participants are not all in the same location, any technology used to conduct the examination must support simultaneous oral interaction between the student and all members of the examining committee. When unusual circumstances arise in the guidance of off campus students, supervisory committees should consult with the Dean of the Graduate School.-

Motion: On behalf of the Committee on Planning, Dr. Ulmer motions to approve Reading Two of the change to Chapter 2, Section D8 "Off Campus Research" as presented for the 2024-2025 AY Graduate Handbook.

### Graduate Handbook Change. <u>Chapter 3, The Doctoral Degree, Section D8,</u> <u>Off Campus Research</u> - Reading One

Rationale for change: Similar language is used in Chapter 2, Section J2 "Scheduling." Delete the paragraph for continuity across master's and doctoral scheduling of examinations.

# D8. Off Campus Research

Special difficulties arise in guiding graduate students when they are engaged in protracted off campus research, whether that research is in the field, in the laboratory, or in the library. Therefore, supervisory committees must take adequate steps to ensure appropriate guidance. As a minimal requirement, the student must submit to the supervisory committee a well formulated research plan, including objectives and methodology, and the committee must

review and approve the plan before the student departs for the research site and indicate approval on the program of study. In addition, the supervisory committee may require:

a. that the major professor and/or a competent local authority who can reliably guide the student provide continuing on-site supervision.

b. that the student provides the supervisory committee with frequent, periodic estimates of performance and progress. The committee may also require that these be authenticated by a competent local authority.

c. that the major professor carries out local inspections of the student's activities.

Regardless of the location at which the research is conducted, the final oral examination must be given on the Manhattan campus. When unusual circumstances arise in the guidance of off campus students, supervisory committees should consult with the Dean of the Graduate School.

Motion: On behalf of the Committee on Planning, Dr. Ulmer motions to waive the second reading of the change to Chapter 3, Section D8 "Off Campus Research" and approve the change for the 2024-2025 AY Graduate Handbook. Vote (YES-NO-ABSTAIN): 19-0-0. Motion carried.

### • Graduate Handbook Change. <u>Chapter 1, "Admissions, Enrollment and</u> <u>Progress," Section C, "Admission Categories"</u> - Reading One

<u>Rationale for change:</u> Slate implementation has provided an opportunity to streamline our admission processes and align policies with practices. As a result of this work, we discussed updating our categories of admission. Criteria for admission do not change. We just label them differently to reflect the practice.

### C. ADMISSION CATEGORIES

All new graduate students, <u>Any student</u> domestic or foreign, are assigned to one of four categories upon admission: pursuing graduate studies at Kansas State University will be classified into one of the following categories:

- Degree seeking (master, doctoral, education specialist)
- <u>Special (accelerated program)</u>
- <u>Credential seeking (graduate certificate or licensure preparedness)</u>
- <u>Visiting (non-degree seeking)</u>

C.1 <u>Full standing</u>A degree seeking student admitted into a master, doctoral, or education specialist program can be admitted into one of the four types listed below if they fulfil the admission criteria listed under each type.

-----a. Undergraduate training essentially the same as that at Kansas State University.

- b. B average or higher in junior and senior years.

a. Full standing

a. <u>Undergraduate training essentially the same as that at Kansas State University.</u>

b.: <u>B average or higher in junior and senior years.</u>

b. Provisional

a.: Transcript evaluation uncertain, as is sometimes the case with international students.

<del>b.</del>: <u>B average or higher in junior and senior years, but some course deficiencies in undergraduate</u> work.

e.: Final transcripts indicating award of a degree not yet in hand; applicant completing degree;

<u>c.</u> Probationary

other criteria for full standing met.

a.: <u>Grade point average from 2.65 to 2.99 (A=4.00) in last two years</u> If work has shown a marked improvement in later semesters and there are grades of B or better in demanding courses in major and related areas, admission is considered.

b. Grade point average below 2.65 in last two years

Admission is considered only upon documentation that the student is now qualified to do graduate work. Evidence may include: (1) satisfactory grades on a GRE Advanced Test or Miller Analogies Test; (2) satisfactory work at another graduate school; or (3) outstanding professional experience that demonstrates the ability to handle academic work in the major area.

<u>Probationary and provisional students are advised of deficiencies and of other conditions to be met to</u> <u>achieve full standing. Their status is reviewed after completing 9 hours of course work at Kansas State</u> <u>University. Those who have earned grades of B or higher and GPAs of 3.0 or higher for the first 9 hours,</u> <u>exclusive of individualized study, and removed all deficiencies specified at the time of admission, will be</u> <u>placed in good standing.</u>

C.2 Provisional <u>Special student (accelerated program)</u>

Students applying for an accelerated Bachelor-Master program are not required to have completed their bachelor degree prior to pursuing the master program. The Special students will be admitted into an accelerated graduate program after fulfilling the admission criteria for the accelerated program. See Chapter 2, section K3.

After admission into the Accelerated program, these students can enroll in up to 9 graduate credits that can be taken over one or more semesters. These credits will count towards both bachelor and master degrees that form the accelerated program.

a. Transcript evaluation uncertain, as is sometimes the case with international students. b. B average or higher in junior and senior years, but some course deficiencies in undergraduate work.

c. Final transcripts indicating award of a degree not yet in hand; applicant completing degree; other criteria for full standing met.

### C.3 ProbationaryCredential seeking student (graduate certificate or licensure preparedness)

Students who have a bachelor's degree but do not plan to work for an advanced master, doctoral, or educational specialist degree can apply for a graduate certificate or licensing preparedness program. Credential seeking students are required to meet the same academic standards as other graduate students. Credential seeking students who later wish to work for an advanced master, doctoral, or educational specialist degree must make a formal application for admission into the degree program and be formally admitted by the Graduate School as degree seeking students with full standing status.

#### a. Grade point average from 2.65 to 2.99 (A=4.00) in last two years If work has shown a marked improvement in later semesters and there are grades of B or better in demanding courses in major and related areas, admission is considered.

#### b. Grade point average below 2.65 in last two years

Admission is considered only upon documentation that the student is now qualified to do graduate work. Evidence may include: (1) satisfactory grades on a GRE Advanced Test or Miller Analogies Test; (2) satisfactory work at another graduate school; or (3) outstanding professional experience that demonstrates the ability to handle academic work in the major area.

Probationary and provisional students are advised of deficiencies and of other conditions to be met to achieve full standing. Their status is reviewed after completing 9 hours of course work at Kansas State University. Those who have earned grades of B or higher and GPAs of 3.0 or higher for the first 9 hours, exclusive of individualized study, and removed all deficiencies specified at the time of admission, will be placed in good standing.

### C.4 SpecialVisiting (non-degree seeking) student

Students who have a bachelor's degree but do not plan to work for an advanced degree may be admitted to graduate study as <del>special</del> <u>visiting</u> students. <u>Visiting students can enroll in one semester and</u> take up to three (3) graduate courses that semester. If the visiting student wishes to continue and earn a graduate degree, they must make a formal application for admission into a degree program and be formally admitted by the Graduate School as a degree seeking student with full standing status. Up to nine (9) graduate credit hours earned as a visiting student may be applied toward the graduate degree. No more than 9 credit hours earned as a special student may be applied toward an advanced degree. Special students are required to meet the same academic standards as other graduate students. Special students who later wish to work for an advanced degree must make a formal application to the appropriate department or interdepartmental program and be formally admitted by the Graduate School as a student with full standing status.

#### C.5 Non-degree, International

International applicants who are in the final year of their undergraduate degree (equivalent to a U.S. bachelor's degree) may be recommended for provisional admission by the graduate program to which they apply. In such cases, those students may be admitted to the graduate school as a non-degree graduate student.

Motion: On behalf of the Committee on Planning, Dr. Ulmer motions to waive the second reading of the changes to Chapter 1, Section C "Admission Categories" and approve the changes for the 2024-2025 AY Graduate Handbook. Vote (YES-NO-ABSTAIN): 19-0-0. Motion carried.

### 8. Assessment and Review Committee – Adam Ahlers, Co-Chair

• Report.

The committee reviewed one new graduate certificate. They did not meet in January because of school closure. The committee helped draft a GTA/GRA Agreement Template, intended as a guideline product for faculty supervisors to use when hiring students for assistantships. The committee will assist Dr. Young in identifying some metrics for the Graduate School Strategic Plan.

Dr. Young noted that he will be having additional discussions with the Associate Provost about graduate program assessment and review so that the Council is prepared to review and provide feedback to departments about their programs when the university resumes program assessment practices.
