Erin Sommer Good, Senior Associate General Counsel in the Office of General Counsel, conducted a short brief on the First Amendment and the rights, roles, and responsibilities of the university and its students. Dean Petrescu introduced the new <u>Mentoring and individual development plans website</u> as a tool for building and maintaining an effective mentor-mentee relationship. Dr. Miller noted that the Graduate School received 65 applications for the Student Parent Success Scholarship—the most received in one semester. There are a range of needs, a large part of which are for babysitting and daycare. However, many students highlighted health challenges, including lack of health insurance, food insecurity, clothing needs, and more. The Graduate School continues to work with the KSU Foundation and the Graduate School Advisory Board to explore ways to improve funding for this scholarship.

# Artificial Intelligence paragraph addition to Chapter 1, Section A "Admission Procedures" - use of AI in graduate admission - *Reading One*

Rationale: There is a basis in university policy for denying graduate applications that use AI-generated content, but the Graduate Handbook should clarify policy for its use in the graduate admissions process. The added verbiage seeks to clarify that submission of personal statements or writing samples that are written using artificial intelligence could be grounds for denying admission.

- 1. ADMISSIONS, ENROLLMENT, AND PROGRESS
- A. ADMISSION PROCEDURES

...

When an applicant is required to prepare a personal statement or writing sample as part of the admissions process, the applicant must be the author of the statement or sample in question. An applicant who submits a personal statement or writing sample that is not their original work, either because it was written by someone else or a software program utilizing artificial intelligence, the applicant will be deemed to have provided fraudulent information and may be denied admission or readmission on that basis.

**Motion #1:** Dr. Ulmer, on behalf of the Committee on Planning, moved to waive Reading Two of the Addition of the Artificial Intelligence paragraph to Chapter 1, Section A "Admission Procedures" in the Graduate Handbook.

**Vote** (YES-NO-ABSTAIN): 17-0-0. Motion carried.

**Motion #2**: Dr. Ulmer, on behalf of the Committee on Planning, moved to accept the addition of the Artificial Intelligence paragraph to Chapter 1, Section A "Admission Procedures" in the Graduate Handbook.

Discussion occurred following the presentation of Motion #2:

A Council member asked if the specific verbiage being added allows for the use of AI for basic

proofreading operations like grammar and typographical errors. Dr. Ulmer and Dean Petrescu responded that the language was developed in concert with the Office of General Counsel and is purposefully general to allow the use of AI for these reasons.

A Council member explained that they, as an AI researcher, feel that the new paragraph is too loose or vague on the following grounds: 1) Lacks language to mitigate confusion about what types of AI are/not permissible (e.g., Grammarly Pro, Microsoft Copilot, etc.); 2) Does not explain how graduate admissions personnel can detect the use of AI; 3) It does not address possible discriminatory harm that the use of AI can have against people of color and poorer students who cannot afford AI software or AI detection software. The Council member recommended that the language be reworked to include these considerations.

Another Council member asked if there is an established appeal process for students whose admission is denied due to the improper use of AI. Dean Petrescu responded that Appendix A of the Graduate Handbook currently allows students to formally appeal directly to the Associate Dean of the Graduate School. Appropriate documentation must be submitted by the department to make a case for disallowing a student admission.

Another Council member noted that AI detection has not been reliable and remarked that the spirit of the added language is deterrence rather than punitive.

There were additional comments about the possibility of introducing risk on the issue of aesthetic judgment and whether additional verbiage could be added to indicate that a submission proven to be fully written using AI is not allowed. Dean Petrescu noted again that the policy language was approved by the Office of General Counsel.

Vote (YES-NO-ABSTAIN): 18-2-1. Motion carried.

Chapter 1, Section A of the current Graduate Handbook will be updated accordingly.

#### 8. Assessment and Review Committee – Phillip Payne, Associate Dean
