## Financial Estimates & Affidavit of Support for International Students (F-1 or J-1 visa holders)

All students, who need a Form I-20 (for F-1) or DS-2019 (for J-1), must provide financial documentation (dated within 1 year) to prove that he/she has sufficient funding to cover his/her expenses equal or greater than the estimated minimum yearly cost for an I-20 or estimated minimum cost for the entire period of study for a DS-2019.

- The estimates listed on the I-20 are based on average student costs. Estimated amount of funding includes tuition and fees, the \$200/semester International Student Fee, room and board, books and supplies, medical insurance, and other expenses. Mandatory health insurance costs are included within the living expenses.
- Actual, individual costs will vary. Kansas State University assigns tuition & fees on a per credit hour basis. Individual students may also be assessed special fees based on specific program or course enrollment. - Students and their sponsors should expect a 5 to 10 percent increase in both tuition and cost of living for each year in attendance.

#### **Additional Financial Support for Accompanying Dependents (spouse or child under the age of 21):**

Please add \$8,000 for the first dependent and \$6,000/each for any additional dependent to the minimum expenses per year. Complete the Request for Dependent I-20 or DS-2019s form, available on the [International Student and Scholar \(ISSS\)](#) website.

#### **Sponsors:**

As an international student, you can have more than one financial sponsor. You can be your own sponsor as well. *However, your sponsor cannot be someone who is holding an F-1 or J-1 non-immigrant student status in the U.S.* Each of your sponsors must complete and sign the Affidavit of Support. The Affidavit of Support must be accompanied by financial support documentation as outlined below.

#### **Financial Support Documentation:**

Applicants shall provide credible documentation of financial support equal or greater than the estimated minimum yearly cost for an I-20 or estimated minimum cost for the period of study for a DS-2019. Keep copies of all financial documentation for your records. Certificates of balance are not acceptable substitutes.

Acceptable documentation includes:

**1) Bank statement** from checking, savings, certificate of deposit, and/or investment account:

- If multiple bank statement pages are submitted, be certain each page clearly reflects the same account.
- If the bank statement is a corporate/business account, a letter verifying sole proprietorship must be provided.
- Investment accounts must be within the most recent quarter and will be valued at 75% .

**2) Bank letter on letterhead** stating the date the account opened, date of current balance, and current balance, or

**3) Scholarship or sponsorship letter** verifying student name, amount of funding (or covered expenses: i.e tuition/fees, living, health insurance, monthly stipend), dates of award, and specifies attendance at Kansas State University..

All documentation must be

- translated in English
- less than 12 months old
- Indicate the currency (Currency will be converted upon review)
- Indicate available amount
- Have the name of account holder match completely on bank statement and Affidavit of Support.
